SUBJECT: Erosion Control of LRT Crossing Abutments at Marconi Avenue,  
El Camino Avenue and Arden Way (PN:XXXX) - Fund Appropriation

SUMMARY

Multiple projects to improve existing overcrossings are to be funded from the Soil Stabilization and Landscaping of Overcrossing CIP program (PN:RC26). To provide accurate design and construction costs, it is recommended that each project, as it is identified, be assigned an individual project number and be funded for project design.

BACKGROUND

The 1989/90 Street Maintenance Capital Improvement Program includes funding for Soil Stabilization of Landscaping of Overcrossings Program (PN:RC26). This is the first year of a multi-year program to improve the stability and appearance of existing overcrossings throughout the city.

Several projects will be funded from this program. To provide accurate cost accounting for each project, it is proposed that an individual project number be established for each project as it is identified. This report recommends establishment of the Erosion Control of LRT Crossing Abutments at Marconi Avenue, El Camino Avenue and Arden Way Project, and appropriates design funds from the current Soil Stabilization and Landscaping of Overcrossings Program. This project will prevent erosion of the embankment slopes at the bridge abutments and will also be designed to be aesthetically pleasing.

There will be no change in the current program scope, schedule or cost, as this action is taken for accounting purposes only. Additional funds for project construction will be appropriated upon receipt of bids.

FINANCIAL DATA

Gas Tax Funds (Fund 202) in the amount of \$350,000 were approved in the 1989/90 Soil Stabilization and Landscaping of Overcrossings Program. The project has a current fund balance of approximately \$350,000. It is recommended that \$50,000 be appropriated for design of Erosion Control of LRT Crossing Abutments at Marconi Avenue, El Camino Avenue and Arden Way Project.

It is recommended that the Budget and Finance Committee approve this fund appropriation and forward this report to the full Council for its approval.



2. That the 1989/90 Capital Improvement Program is further amended by transferring \$50,000 from the Soil Stabilization and Landscaping of Overcrossing Program (PN:RC26; JN:2041) (Fund 202) to the Gas Tax Contingency Reserve as follows:
