TYPICAL EXTRUSION PROFILES



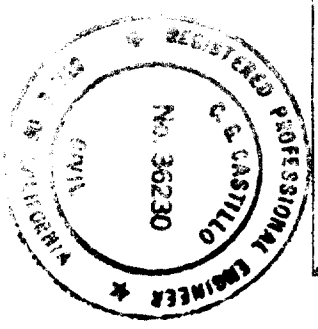
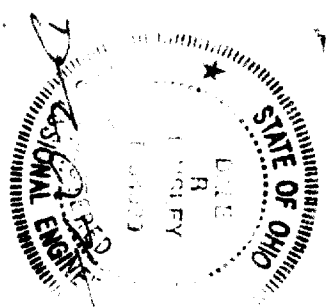
