Funding for this purchase is available in Fleet's budget lines for new and replacement vehicles with a remaining balance of \$3,478,488.07.


#### POLICY CONSIDERATIONS

This recommendation is consistent with the requirements for competitive bidding as detailed in Chapter 57 of the Sacramento City Code.


#### MBE/WBE
