

**RESOLUTION NO. 2014-0341**

Adopted by the Sacramento City Council

**APPROPRIATE AND TRANSFER FUNDS AND AWARD CONTRACT: 12<sup>TH</sup> STREET CORRIDOR SAFETY IMPROVEMENT PROJECT (T15115000)**

**BACKGROUND**

- A. The project will enhance public safety for pedestrians, bicyclists and vehicular traffic, and improve the light rail vehicle preemption along 12<sup>th</sup> Street between Sproule Avenue and J Street.
- B. The project was advertised and bids were received on May 21, 2014. The bids are summarized below:

M&M Electric	\$979,940	92.3%
Pacific Excavation Inc.	\$999,584	11.0%

- C. The Engineer's estimate is \$836,632.
- D. Construction is expected to begin in November 2014 and be completed in March 2015.
- E. On April 3, 1985, the Sacramento Regional Transit District (RT) and the City entered into the Sacramento Light Rail Systems Operations Agreement No. 84165 (Operations Agreement). The Agreement provides the terms under which RT operates and maintains a light rail system within the city limits. It includes a provision that whenever the City undertakes new project construction in the vicinity of the light rail system, RT is obligated to pay that portion of design and construction costs that are directly attributable to the existence of the light rail system.

**BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:**

- Section 1. The Plans and Specifications for the 12<sup>th</sup> Street Corridor Safety Improvement Project (T15115000) are approved.
- Section 2. The transfer of \$450,000 (Fund 2001) from the State and Federal Grant Match Project (T15007200) to the 12<sup>th</sup> Street Corridor Safety Improvement Project (T15115000) is approved.

- Section 3. The transfer of \$250,000 (Fund 2007) from the Major Street Improvements Project (T15128000) to the 12<sup>th</sup> Street Corridor Safety Improvement Project (T15115000) is approved as a funding source until funds are received from RT.
- Section 4. The appropriation of \$810,000 (Fund 3703) in Federal Highway Safety Improvement Program Grant funds to the 12<sup>th</sup> Street Corridor Safety Improvement Project (T15115000) is approved.
- Section 5. The contract for the 12<sup>th</sup> Street Corridor Safety Improvement Project (T15115000) is awarded to M&M Electric in an amount not to exceed \$979,940.
- Section 6. The City Manager is authorized to execute a contract with M&M Electric for an amount not to exceed \$979,940 for the 12<sup>th</sup> Street Corridor Safety Improvement Project (T15115000).
