SUBJECT: AGREEMENT FOR FUNDING FOR THE SACRAMENTO OPERA

LOCATION AND COUNCIL DISTRICT:

City of Sacramento, All Council Districts

County of Sacramento, All Supervisorial

Districts

RECOMMENDATION:

It is recommended that the Sacramento City Council and Sacramento County Board of Supervisors adopt a resolution to:

- (1) Approve an agreement between the City of Sacramento, County of Sacramento and the Sacramento Opera Association for a grant not to exceed \$75,000 each from the City and County for short-term financial stabilization for the Sacramento Opera.
- (2) Designate the payment as a grant and not subject to repayment if the Sacramento Opera meets the following conditions:
 - (a) The Sacramento Opera will work with the Metropolitan Arts Commission and National Arts Stabilization Inc. to identify critical financial issues and complete a long-term stabilization plan that contains, but is not limited to, the following:

- 'Verification of financial need by an independent accountant.
- Plan to address accumulated debt.
- Plan to address shortfalls.
- Financial plan for the next three years that decreases reliance on deferred income, eradicates debt, creates cash reserves, rebuilds endowment and invests in infrastructure.
- Completion of financial audit
- Plan for community outreach.
- (b) The Opera is committed to establish a trust account to deposit season ticket revenues to be used exclusively for opera production expenses.

Failure to meet the above conditions would result in the grant being considered a loan and subject to repayment.

(3) Approve an agreement between the City of Sacramento and County of Sacramento whereby the County would guarantee 25 percent of the outstanding debt, not to exceed \$25,355, owed to the City by the Sacramento Opera. The current outstanding City loan balance is \$76,781 and balance due the Community Center Theater is \$24,638 for a total of \$101,419. Twenty-five percent of that total is \$25,355.

SUMMARY:

This report recommends approval of up to \$75,000 from the City of Sacramento and up to \$75,000 from the County of Sacramento to the Sacramento Opera to meet short-term operating and production expenses. These funds would be considered a "grant" if the Sacramento Opera meets certain conditions to address critical financial issues. The report also recommends approval of an agreement between the City and County whereby the County guarantees 25 percent of the current Sacramento Opera debt owed to the City, not to exceed \$25,355.

BACKGROUND INFORMATION:

Current Situation

- The Sacramento Opera was founded in 1947. It has an annual operating budget of \$837,116, an administrative staff of 2.50 FTE and a 24-member Board of Directors (9 current vacancies). The Opera has 2,460 season ticket subscribers and in a typical year produces two operas.
- The Sacramento Opera has experienced severe financial and organizational instability in recent years that threatens its continued viability. Like some local arts organizations, the problems facing the Opera include: (1) use of deferred revenue, (2) borrowing from boards and endowments, (3) high accumulated debt, (4) no cash reserves or method to deal with annual cash flow shortages, and (5) no financial planning or plan to invest in its infrastructure.
- The City of Sacramento has provided loans to the Sacramento Opera or carried balances due to the Community Center Theater. The current outstanding loan balance is \$76,781 and balance due the Theater is \$24,638 for a total of \$101,419.
- In August 1998, the City Council approved a \$335,000 short-term arts stabilization plan for the Sacramento Ballet, Sacramento Opera and Sacramento Theater Company. The plan included (1) monthly grants to the Ballet and Theater Company to deal with critical cash-flow deficits; (2) a one-year deferral of repayment for City, SHRA and County loans, and (3) a contract with National Arts Stabilization Inc. to provide a major technical assistance program to these groups for financial and organization planning. At that time, the Sacramento Opera did not identify a projected shortfall, so no funding was provided. Due to staff turnover and incomplete financial statements dating back to 1996, the Opera did not have the infrastructure to complete a short-term stabilization plan.
- In March 1999, the City Council and County Board of Supervisors approved a Long-Term Arts Stabilization Program. This included a three-year extension of deferred loan payments for the Sacramento Ballet and Sacramento Opera, with repayment resuming in FY 2003.
- In February 2000, the Sacramento Metropolitan Arts Commission approved a Bridge Loan of \$15,200 and a \$3,000 grant to the Sacramento Opera for temporary cash flow needs. The Opera's 2000 Cultural Awards Grant guarantees the loan. For each of the next two years, the Opera will receive an additional \$15,200 in Cultural Awards Grants for a total of \$30,400.

Recommended Action

The recommended actions address both short-term stabilization for the Sacramento Opera and long-term sustainability.

• Approve a grant of up to \$75,000 each from the City and County for short-term operational and production expenses. The grants would be disbursed under the schedule shown below and would represent 93 percent of the Opera's projected deficit for May and June of this year based on their most recent cash flow projections. Total City/County funding would not exceed \$150,000.

Payment 1	\$85,850	no later than May 15, 2000
Payment 2	\$32,075	no late than June 15, 2000
Payment 3	\$32,075	no later than June 25, 2000

- The Sacramento Opera will work with the Metropolitan Arts Commission and National Arts Stabilization to identify critical financial issues and complete a long-term stabilization plan that contains, but is not limited to, the following:
 - Verification of financial need by an independent accountant.
 - Plan to address accumulated debt.
 - Plan to address shortfalls.
 - Financial plan for the next three years that decreases reliance on deferred income, eradicates debt, creates cash reserves, rebuilds endowment and invests in infrastructure.
 - Completion of financial audit
 - Plan for community outreach.
- The Sacramento Opera is committed to establish a trust account for the deposit of season ticket revenues for all future seasons. These revenues would only be used for production expenses.
- The County of Sacramento will guarantee 25 percent of the outstanding balance owed the City by the Sacramento Opera, not to exceed \$25,355.
- On April 25, 2000, the Board of Directors of the Sacramento Opera Association approved a resolution (Exhibit A) accepting the Agreement for the proposed grant funding.

FINANCIAL CONSIDERATIONS:

Based upon their most recent cash flow projections, the Sacramento Opera will have an operating deficit of approximately \$162,000 on June 30, 2000. Total recommended City/County grant funding would be \$150,000—approximately 93 percent of the total. The Opera would address the remaining shortfall through expense reductions and/or additional fundraising. It is recommended that the City's \$75,000 in grant funding would come from unallocated General Fund revenues set-aside for arts programming. The County's \$75,000 grant funding would come from unallocated reserves in the Transient Occupancy Tax Fund.

Funding for the Sacramento Opera's independent verification of financial need, financial audit and consultation by National Arts Stabilization Inc., all conditions of the grant, will come from existing General Fund revenue set-aside for arts stabilization.

If approved, the County would guarantee 25 percent of the current Sacramento Opera debt owed the City. The current outstanding City loan balance is \$76,781 and balance due the Community Center Theater is \$24,638 for a total of \$101,419. Twenty-five percent of that total is \$25,355.

This recommended actions are consistent with the following City/County policies:

- Promoting excellence in arts programming;
- Enhancing stability and development of Sacramento's arts organizations;

- 2. The City Manager is authorized to execute an agreement between the City of Sacramento and the County of Sacramento whereby the County would guarantee 25 percent of the outstanding debt owed to the City by the Sacramento Opera, not to exceed \$25,355.
