SUBJECT: PLANNING AND DEVELOPMENT DEPARTMENT REPORTS BACK

SUMMARY

The Planning and Development Department has completed a review of the follow-up log for City Council and Council Committee meetings from October 1989 - April 1991. This report includes a list of the pending reports and a list of current issues/studies and major projects in the Planning Division with a recommendation for prioritizing workload in the Division.

BACKGROUND INFORMATION

In addition to the day to day responsibilities of field inspections, substandard housing review, plan check, weed, sign and nuisance abatement, current planning activities, environmental review and permit processing, Department staff is continuing it's responsibility working on major projects such as Centrage, Coke/Raley's, Pacific Plaza, R Street. (A complete list of major projects currently in process is found in Exhibit B.) There are also many long term issues such as the update of the General Plan and an update of the zoning ordinance that need to be incorporated into the work program. There are currently 68 neighborhood groups that require notice of meetings and request staff participation in meetings.

A review of the follow up log for City Council meetings from October 1989 to April 1991 was recently completed. The Department has identified 39 items from that 18 month period that require a report back. All but one (1) item requires a report back from the Planning Division.

Exhibit A is a listing of all pending reports back. They have been ranked into three (3) groups: high priority, medium priority, and low priority. Staff have established as high priority those issues that are mandated by law or those that are identified and budgeted for in the Division's current work program. Items are not ranked within each group. The Department needs Committee input and we request that the members of the Joint Transportation and Community Development/Budget and Finance Committee review the staff recommendations and forward their individual responses to the Planning and Development Department within the next two (2) weeks. A final report will be scheduled for the committee meeting on June 11, 1991. This report will include recommendations based on responses collected and the department's resources available to perform the work. The list that will be developed will identify the department's responsible staff members and the projected due date for the report. Once this list is established, the department will update and present the list on a quarterly basis for review and evaluation by the Joint Council Committee. Additional Committee and City Council requests will be included in the quarterly lists and completed projects deleted.

Exhibit B is a list of current studies and major projects (in addition to the reports back) in the Planning Division. This list has also been prioritized into high, medium and low priority groups again taking into account budget, staffing and legal mandates.

The purpose of this report is to request council policy assistance in prioritizing the workplan of the Department. The final product will allow staff to focus its efforts on items of importance, establish completion dates within available resources and maintain improved communication between the Department, Managers Office and City Council on pending projects. Of critical importance to the success of this effort is to eliminate or postpone low priority projects to insure quality staff time is provided for priority projects.


