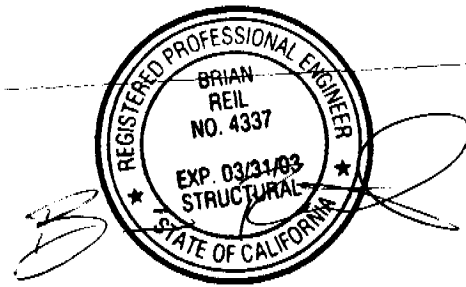

The Contractor has requested a change or deletion of detail 4 on S5.2. This was due to the fact that there is no longer a rail attaching to the closure plate. Section A/S3.1 was revised to show the closure without the reinforcing. Detail 4/S5.2 was not revised, however and no longer applies along the perimeter of the structure. The closure plate only needs to support the concrete while being poured. The only location where there is to be 1/4" plate with welded rebar is along the elevator per the fax dated March 2, 2001.
