

Sacramento, California,  
February 16, 1931.

The Civil Service Board of the City of Sacramento met in special session on the above date at 7:00 o'clock P. M. in the office of the Board, Room 106 City Hall, President Chenu presiding.

PRESENT: Commissioners Maloney, Weisman, and Chenu.  
ABSENT : None.

The minutes of the special meetings of February 6, February 10, and February 11, 1931, were read and approved as read.

The Board gave consideration to the appeal of Mr. Fred Hanson for a review of his case. Mr. Hanson was a candidate in the recent test for Laborer, being disqualified for misstatements in application as to residence.

Commissioner Maloney moved that Mr. Hanson's case be reviewed by the Board. The motion was seconded by Commissioner Weisman. The vote was as follows:

AYES: Commissioners Maloney, Weisman and Chenu.  
NOES: None.

Upon completion of the review, Commissioner Maloney moved that Mr. Hanson be allowed to take the prescribed test for Laborer. The motion was seconded by Commissioner Weisman. The vote was as follows:

AYES: Commissioners Maloney, Weisman and Chenu.  
NOES: None.

Mr. Hanson was called before the Board, examined, and excused. The Board thereupon established the grade obtained by Mr. Hanson in the test.

Commissioner Maloney moved that in view of the fact that the result of the test disclosed that Mr. Hanson had received a passing

grade, that his name be placed in its proper place upon the eligible list. The motion was seconded by Commissioner Weisman.

The vote was as follows:

AYES: Commissioners Maloney, Weisman and Chenu.  
NOES: None.

Consideration was given to the case of John Frei who passed the test given for Laborer, but who failed to take the physical examination required within the specified time, due to the announcement directing him to take the physical examination not being forwarded by the post office.

Commissioner Maloney moved that under the circumstances Mr. Frei be permitted a physical examination, and if successful in the test, his name placed in its proper order on the eligible list for Laborer. The motion was seconded by Commissioner Weisman. The vote was as follows:

AYES: Commissioners Maloney, Weisman and Chenu.  
NOES: None.

The prevailing salary scale for Garbageman was discussed by the Board. The Secretary was instructed to confer with the City Manager relative to the variance in the present scale.

The classification of Truck Driver was next considered. It was the sense of the Board that no positions of this character and classification existed in the Park Department at the present time.

A report of the proceedings of the City Council as of February 13, 1931, showing action taken upon the communication addressed to that body by the Civil Service Board, was read. The report was ordered filed.

The Board next proceeded with the Personal Fitness Test for Uniform Fireman. Twenty-five candidates were examined.

Adjournment was taken at 12:00 o'clock P. M. to meet again
