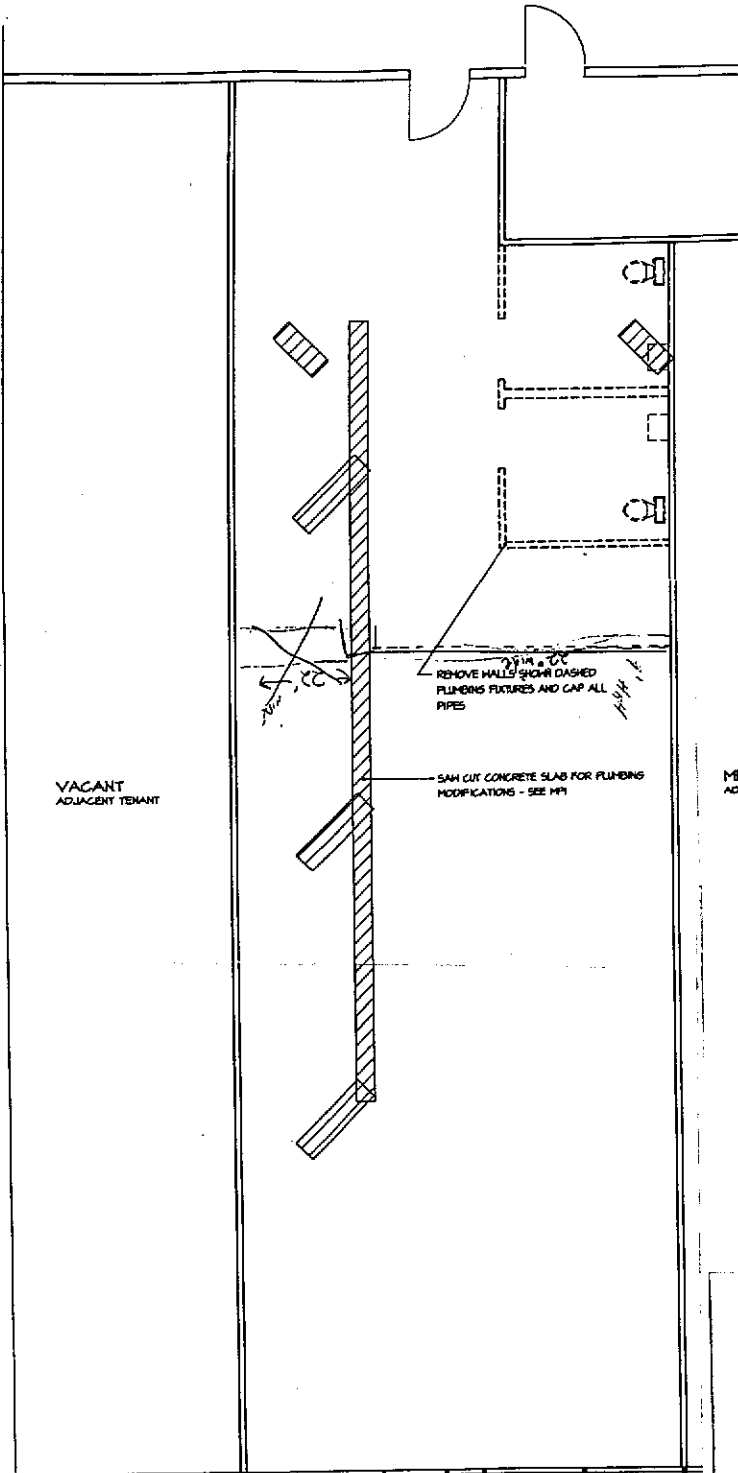

- U. PROVIDE AT ALL PUBLIC RESTROOMS:
 - a. A 1/4" THICK x 12" SQ. MEN AND WOMEN/SEX GEOMETRIC SIGN 60" ABOVE FLOOR ON RESTROOM ENTRANCE DOORS.
 - b. TWO RAISED LETTER/BRILLE SIGNS ON LATCH-OUTSIDE OF RESTROOM ENTRANCE DOORS, MOUNTED ON HALL 60" ABOVE FLOOR, ALLOWING APPROACH WITHIN 3".
 - c. 42" LONG SIDE AND 36" LONG REAR GRAB BAR AT 35" ABOVE FLOOR AT TOILETS.
 - d. TOILET SEAT TOPS SHALL BE WITHIN 11" - 14" ABOVE THE FLOOR. TOILETS SHALL REQUIRE MAXIMUM 5 LBS. OPERATING FORCE.
 - e. TOILET SIDE CLEARANCE SHALL BE 20" TO A FIXTURE & 32" TO A HALL.
 - f. TOILETS SHALL BE CENTERED 15" FROM HALL.
