

RESOLUTION No. 4255
APPROVING PLANS AND SPECIFICATIONS
FOR SEWER CONSTRUCTION WORK,
APPROVING PRIVATE CONTRACT FOR WORK,
CONSENTING THAT WORK BE DONE IN PUBLIC STREET
AND
PROVIDING THAT BUILDER RETAINS TITLE TO WORK

WHEREAS, the City Engineer has this day presented to this Council certain plans and specifications which show the construction details of a Sanitary Sewer Trunk Line proposed to be constructed in the easterly one-half of Center Parkway from its intersection with Mack Road to its intersection with Bamford Drive and in the southerly one-half of Bamford Drive from its intersection with Center Parkway to a point approximately 283 feet easterly therefrom and which show the construction details of a Storm Drainage Sewer Trunk Line in the westerly one-half of Center Parkway from its intersection with Mack Road to its intersection with Bamford Drive and from its intersection with Alvern Way to a point approximately 166 feet southerly therefrom and in the northerly one-half of Bamford Drive from its intersection with Center Parkway to a point approximately 271 feet easterly therefrom, and

WHEREAS, the City Engineer has this day presented to this Council a contract that M. J. Brock & Sons, Inc. as OWNER proposes to execute with Teichert Construction as CONTRACTOR, which contract binds the said CONTRACTOR to construct said Sanitary Sewer Trunk Line and said Storm Drainage Sewer Trunk Line at their respective locations shown above, and binds said OWNER to pay said CONTRACTOR the sum of \$60,489.00 as the total price for constructing said Sanitary Sewer Trunk Line, and said Storm Drainage Trunk Line, and

WHEREAS, the City Engineer has this day sent his written recommendation to this Council requesting that this

Council shall approve said plans and specifications and permit said Owner to execute said contract and grant permission to said CONTRACTOR to construct said Sewer Line and said Storm Drainage Trunk Line in said Center Parkway, and Bamford Drive public streets in this City, and

WHEREAS, the City Engineer has informed this Council that said Owner desires to retain title to said Sanitary Sewer Trunk Line and said Storm Sewer Trunk Line at all times from the commencement of their construction to the completion of their construction,

NOW, THEREFORE,

RESOLVED BY THE CITY COUNCIL OF THE CITY OF SACRAMENTO

That respecting the matters stated in the recitals to this resolution this Council hereby:

- (a) Approves the said plans and specifications,
- (b) Approves the proposed construction,
- (c) Approves the proposed contract price, and
- (d) Approves that said Owner shall retain title to the items said Owner will build in the public street right of way under said contract.
