IV. COMMITTEE REPORTS:

ARTS EDUCATION & OUTREACH: Arts Education Coordinator Gee reported. Artist in Schools applications have been extended to Friday, October 18, 1996. Marion Anderson Elementary School begins residency program week of October 21. Sacramento County Waste Management wants to assist in doing a mural project. The Cultural Resource Directory is being updated. The next AEO Committee meeting is scheduled for October 21, 1996, City Hall, Room 302. Tony Marques will give a presentation on Arts Education & Outreach Committee in November.

Arts Education Coordinator Bruton reported. There are ten projects going out in November. In school programs, working on a 10 foot mural on 16th Street, Stage Kraft program, and the literary arts program at Mather Airforce. SMAC held a workshop with the Sacramento Department of Education in September inviting artists to meet with teachers. It was a very valuable experience because artists were able to meet other artists in the Artist in Schools program, and they were able to speak to teachers who didn't have the programs in their schools as yet. In January, a workshop will be held to bring the artists up to date on the state framework policies used in the schools.

AWARDS COMMITTEE: Grants Program Coordinator Heller reported. Heller passed out a copy of the Cultural Awards list of panelists who will be serving on the Cultural Awards panel October 21-23 at the Kampala Center (Zoo). Each Cultural Awards application at the panel meeting is reviewed and discussed for 20 minutes.

Grants Program Assistant, Dale Moon, has set up a brainstorming panel to discuss the Fellowship grant (Dance). Community Enhancement grants have been distributed. Friends of the Sacramento Metropolitan Arts Commission is planning a reception for the New Works recipients November 8.

INTRODUCTION OF NEW MEMBER: Chair Kamilos introduced new Commissioner, Marcy Friedman, and stated that Marcy has done an exemplary job in both the community and as a member and chair of the Art in Public Places Committee. VII. DISCUSSION ITEM(S): Matt Powers, Deputy Chief of Police, and Jane Christenson, Administrative Analyst II, presented an overview of a budget balancing process titled "Sacramento Decisions." The intention of Sacramento Decisions is to educate the City's residents about budget realities through dialogue, ask residents how they would balance the budget, where they would make the cuts, and what revenue they would raise. The City Council will use the accumulated information as they deliberate the issues surrounding the final budget decision.

The tools used to gather information from the public are 200,000 tabloids that will be distributed to every household in the City of Sacramento, surveys that will be conducted to provide results representative of the overall community, and community workshops that will be held to generate community discussion and solutions. Round I, soliciting community feedback on spending priorities and revenue preferences, begins September 1996 with workshops scheduled November 13 and 14. Round II, obtaining community input on specific budget strategies and proposals, occurs January 1997 with workshops occurring in March.

Questions for the surveys are being developed in a community based way by Professor Edward Weeks in conjunction with CSUS professors with the assurance that there will be balanced questions in the survey. The surveys will be written in different languages, excluding the budget worksheet, however, language translators and workshops are under consideration to help translate documentation and assist community members.

Community members are encourage to attend the workshops and a project hotline for general questions will be available.

Discussion item "Commissioning local artists and developing technical assistance that benefits them" was moved to the next Commission meeting that will be held November 20, 1996.

Meadowview Community Center- Phase II

- Project Name:** Meadowview Community Center, Phase II
Location: Meadowview Road and 24th Street, Sacramento, Ca.
- Description:** Artist will work with project architect to create site-specific artwork.
- Art Budget:** \$37,000 for all materials, labor, and time involved in the design, fabrication, and installation of the artwork.

THE SITE

The City of Sacramento will be constructing an addition to the existing Meadowview Community Center. The new structure will accommodate conference rooms, staff offices, and several activity rooms. The main feature of the new construction will be a courtyard area with wall dimensions of 30'X50', incorporating a water feature, lighting, and trellis (see site plans.)

THE PROJECT

The Sacramento Metropolitan Arts Commission is seeking an artist to collaborate with the project team (including City Staff, the project architect, Art in Public Places committee members, and a citizen's advisory committee) to design site-specific artwork for the Meadowview Community Center-Phase II. The selected artist will be required to make site visits, demonstrate sensitivity towards an ethnically diverse community and multicultural issues, and work closely with volunteers of all ages.

Applications must include:

- 1) A proposal for the courtyard wall.
- 2) A design for the concrete floor in that same space.
- 3) An Arts Plan for remaining areas. Other opportunities for artwork include, but are not limited to, interior corridors, ceilings, floors, walls, reception desk and planters.

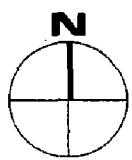
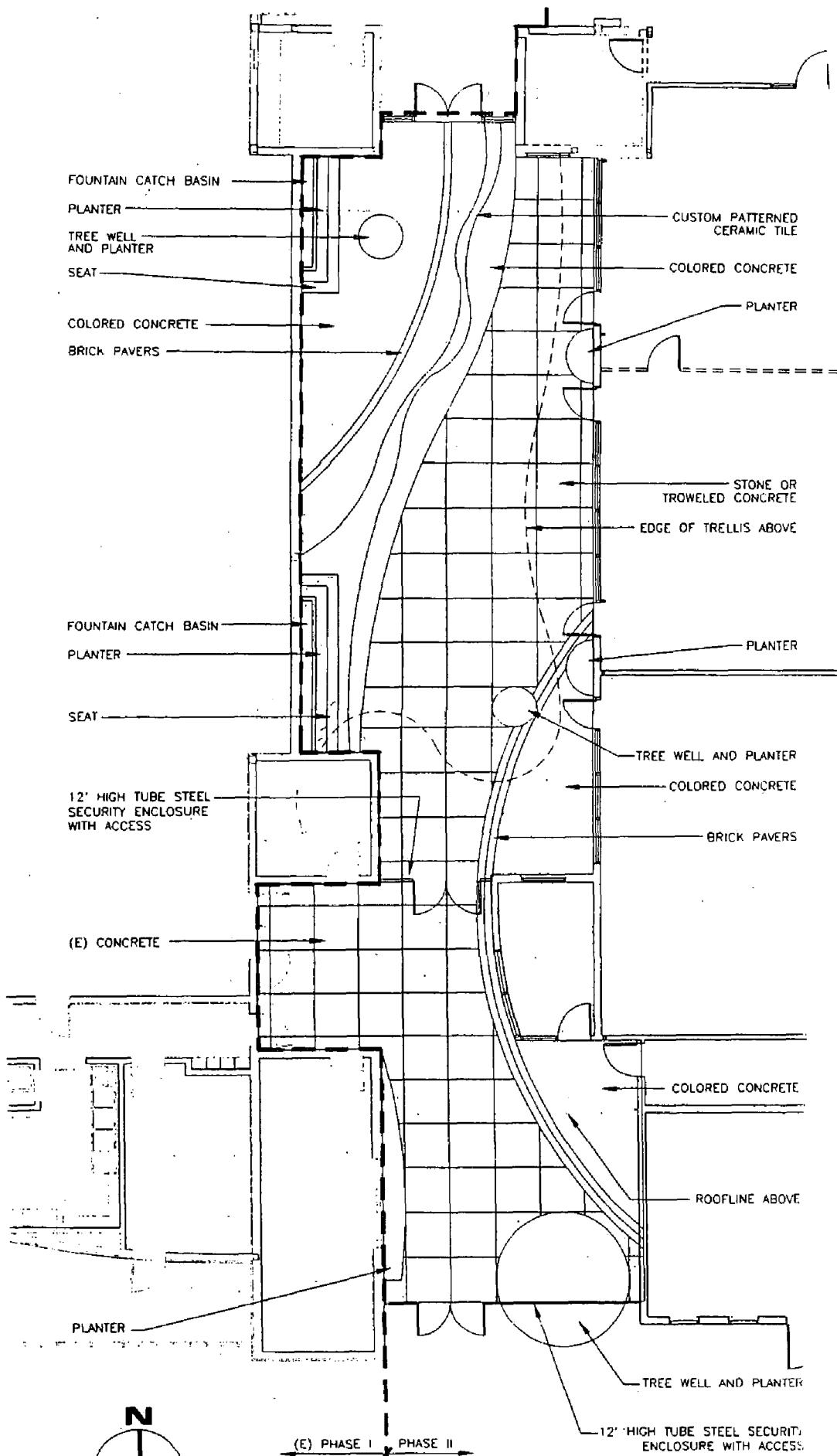
ARTIST SELECTION PROCESS

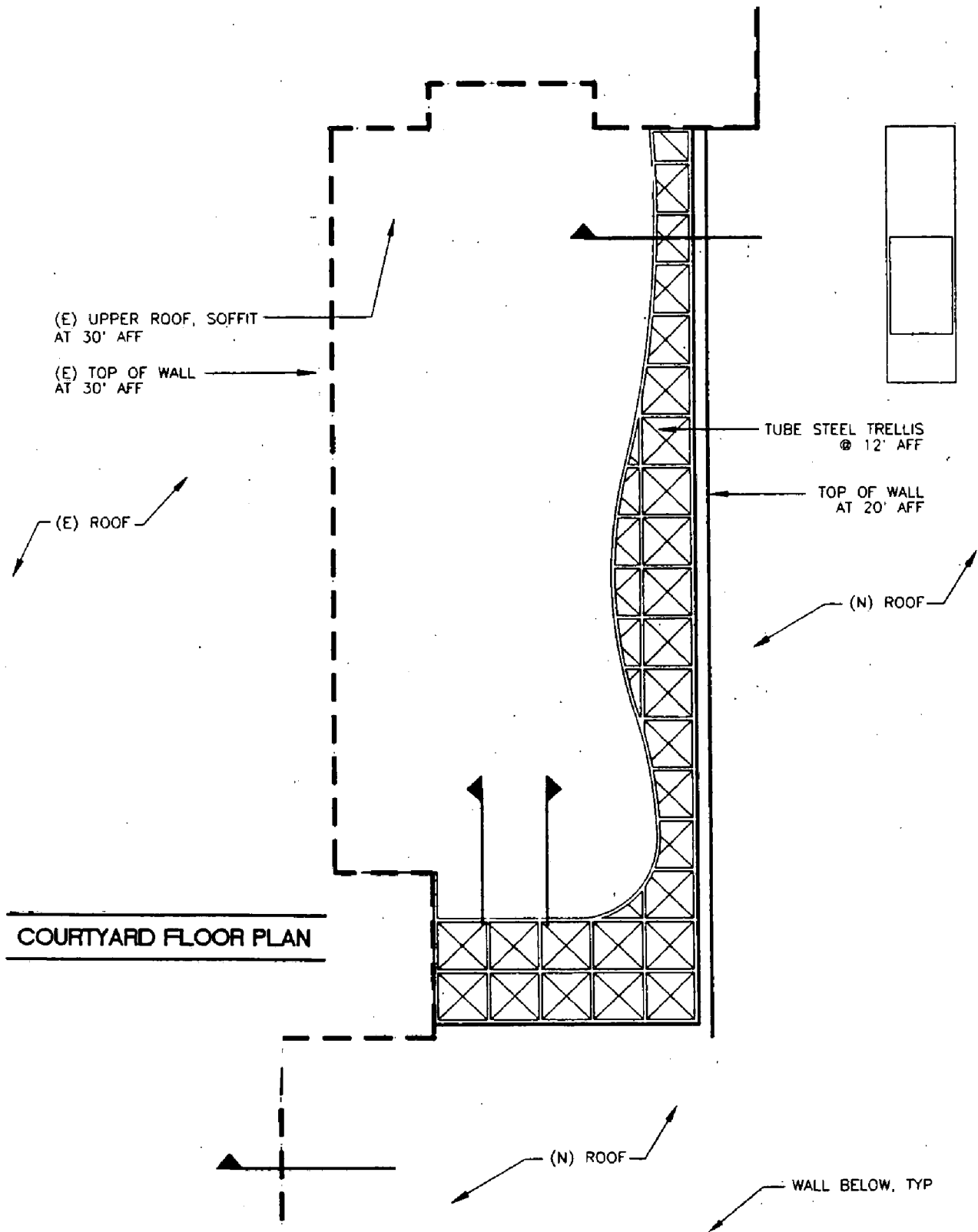

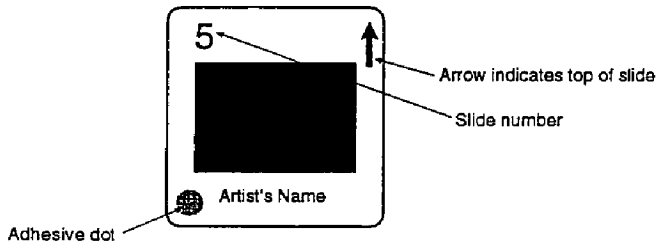


Later on, Ricardo assisted Enrique Aberle in the landscape design of the west wing of the National Zoo in San Salvador in 1977.


