SUBJECT: Increase in Office of Traffic Safety Grant

SUMMARY

This report recommends that: 1) the City Council accept the State Office of Traffic Safety grant increase; and 2) amend the Mayor's Safety Belt Program operating grant budgets by \$106,757. This item was heard by the Budget and Finance Committee on September 15, 1987.

BACKGROUND

In December, 1984, the City accepted a grant from the State of California Business, Transportation & Housing Agency, Office of Traffic Safety. The grant, covering the period December 3, 1984 to November 30, 1986 and in the amount of \$249,884, was for the City to develop and implement, through the Mayor and City Manager's offices, a comprehensive safety belt and safety seat public awareness program.

The Office of Traffic Safety has increased the grant award to target the traffic safety implications of drunk and drugged driving in the City of Sacramento and county communities.


FINANCIAL

The augmentation to the grant award is \$106,757 and extends the grant through November 30, 1987.

RECOMMENDATION

It is recommended that the City Council accept the increased award from the Office of Traffic Safety and amend the operating grant budgets of the Mayor's Safety Belt Program.
