Mrs. Giles requested that this matter be held over to the next regular meeting of the Civil Service Board, as the meet and confer process had not been completed. There were no objections.


Motion was made to continue discussion on the Proposed Amendment to Civil Service Rule 3.7 to the next regular meeting.
