SUMMARY

Attached is a resolution by which certain officers of the Redevelopment Agency are designated to execute Certificates of Acceptance on behalf of the Redevelopment Agency of the City of Sacramento.

BACKGROUND

Government Code Section 27281 provides that deeds and grants conveying any interest in real property to a public agency for public purposes shall not be accepted for recordation without the consent of the public agency evidenced by its Certificate of Acceptance attached to or printed on the deed or grant. This Section further provides that the Redevelopment Agency may designate by resolution those persons who can execute the Certificate of Acceptance to accept and consent to such deeds or grants.

The attached resolution designates the Interim Executive Director, the Deputy Executive Director and Assistant Director-Community Development to execute Certificates of Acceptance on behalf of the Redevelopment Agency. Adoption of this resolution is necessary at this time in order to implement internal procedures in connection with pending Redevelopment Agency activities in the City.
