Cal Fed Server Room Scope of Work

The scope of this project is to install a 2-Ton Trane Split System cooling unit to serve a Computer Server room.

The fan coil unit will be installed in the ceiling above the server room and ducted into the server room. The condensing unit will be mounted on the roof and the refrigerant piping will be run through the ceiling space and through a chase to the fan coil unit.

The condensing unit is a Trane Model TTB-024C100A (unit weight is 125#)
The Fan coil unit is a Trane Model TWE-024C140B (unit weight is 105#)

Please see attached documentation to confirm the above unit weights.

The existing room ventilation will be left intact to provide minimum fresh air requirements.
