

Sacramento, California,

The Civil Service Board of the City of Sacramento met in special session on the above date at 7:30 o'clock P.M. in the office of the Board, Room 106 City Hall, President Chenu presiding.

PRESENT: Commissioners Mason, Weisman and Chenu.  
ABSENT : None.

The minutes of the special meeting of December 18, 1929, were read and approved as read.

Upon motion by Commissioner Weisman, seconded by Commissioner Mason, and unanimously carried, the following opinion from the City Attorney, concerning the right of Commissioner Mason to serve on the Board, was ordered spread upon the minutes:

"Colonel Mason holds until his successor is appointed and qualified. The general rule applies.

This is a different case from a Councilman; there the election is at large and it cannot be said any one to be elected is to succeed a particular person.

The Board gave consideration to Question No. 15 in the promotional examination recently held for Captain in the Fire Department. It was the sense of the Board that if the question were answered, "The Captain shall station himself with his company," that this would be considered a correct answer, as would also the answer as given in the Fire Manual, Section 38, Page 8.

Due to the fact that the foregoing question was allowed, the Board reviewed the examination papers. (Rule 3, Section 15, Civil Service Regulations.)

✓ A communication was received from Mr. Eugene Connolly wherein he

requested the Board to review his examination papers for Captain in the Fire Department. Mr. Connolly's paper was reviewed and no material change was made therein that might affect his standing. The Secretary was instructed to inform Mr. Connolly of the Board's findings.

A communication was received from Mr. Hugh B. Bradford, City Attorney, with reference to the case of J. C. Coyle, an officer in the Police Department whose case was pending awaiting a decision from the City Attorney.

Upon motion by Commissioner Mason, seconded by Commissioner Weisman, and unanimously carried, the Board determined that Mr. J. C. Coyle, due to his prior service on the previous Desk Sergeant's eligible list, should have priority over any list for Desk Sergeant that might now be established. This action was taken in accordance with the opinion of the City Attorney.

The Board next proceeded to administer the Personal Fitness test. Twenty-three candidates were interviewed. Upon completion of this test, the following eligible list was established:
