### Application for Building Code Compliance Inspection

A building code compliance inspection is a general inspection of a building or portion of a building to determine whether it is safe and in substantial compliance with the City Building Code. A compliance inspection is only provided when a building is to be sold or refinanced; in no way can it be used as a substitute for the permit inspections required by Section 108, "Inspections," of the City Administrative Code. The fee for a single-family residence or a portion thereof is \$250. The fee for a commercial compliance inspection is \$250. Fees are paid when the application is completed. When ready for inspection, telephone 808-5716 between 7:00 a.m. and 4:00 p.m. The Building & Safety Department will respond to the inspection request as soon as possible.

The inspection covers only those items that are visible for inspection and does not include any portion of the building that is below ground; inside walls, floors, and ceilings; or that cannot be readily viewed during the inspection. The inspection is only available on work completed prior to August 29, 1988.

The building inspector may request permits, additional plans, calculations, soil reports, or other information where there is evidence that a hazardous situation may exist or there is evidence of substandard construction methods. Any building alterations or corrective work necessary to comply with City Building Code provisions will require a permit from the City before work is started. This Code Compliance Inspection is valid for a maximum of 90 days from date of issuance.
