The Secretary was thereupon requested to prepare a written rule with reference to vacation and sick leave benefits for part-time and seasonal employees.

FINGERPRINT TECHNICIAN

Communications from the Chief of Police and Superintendent of the Identification Bureau, requesting

reclassification of one Junior Fingerprint Technician position in the Fingerprint Bureau to Intermediate Fingerprint Technician, was considered.

After reviewing the duties of said position and the Board having determined that the present duties are within the scope of the position specification for Intermediate Fingerprint Technician, Mr. Deise moved that one position of
