STAFF ACTION AND CONDITIONS OF APPROVAL:

Staff has reviewed the proposed project, and approves it with the following conditions of approval:

1. Provide new stucco siding at all elevations of existing home. Stucco shall have a smooth finish.
2. All windows, vents and doors shall have stucco trim. All street-facing windows shall have stucco trim and sills.
3. Repair/Replace existing fascia board as required, there shall be no change to existing fascia board dimensions.
4. Paint entire house, paint all trim, fascias and exposed wood a complimentary, accent color.
5. The scope of exterior work is limited to the above listed items. Any changes are subject to Design Review staff approval.
