SUBJECT: CITY POLICY RE OUTDOOR VENDING ON PRIVATE PROPERTY

SUMMARY

This report describes current City regulations relating to outdoor vending on private property and recommends that the Law and Legislation Committee provide direction to staff.

BACKGROUND INFORMATION

Councilmember Josh Pane has requested that the Law and Legislation Committee review the City's regulations relating to outdoor vending from private property. The regulations are found in Chapter 7.07 of the City Code (copy attached). Generally, the City Code makes it unlawful to sell, attempt to sell, or display for sale any merchandise, food or drink on private property except from within a fully enclosed building. Exceptions to the general rule include:

1. Display of merchandise outside a fully enclosed building, in association with a business where purchase of such merchandise ordinarily takes place within the building (sidewalk sales or displays).

2. Automobile, boat, trailer, camper, motorcycle and construction equipment sales and rental.
3. Retail lumber yards, horticultural nurseries, Christmas tree sales, fireworks sales.
4. Fruit and vegetable stands with a valid special permit from the City Planning Commission.
6. Vending machines, when located in service stations, motels, and other "drive-in" businesses, and gasoline pumps, oil racks and accessory items when located on pump islands.
7. Sale of newspapers, books, periodicals and other printed material.
8. Yard sales (maximum one per calendar year not to exceed two consecutive days).
9. Mobile health and veterinary clinics.
10. Fund-raising activities conducted by organizations exempted from the business operations tax by Section 23.01.103(b) of the Sacramento City Code (charitable organizations known as 501(c)(3)'s).
11. Flea markets.

Any violation of these regulations is an infraction, punishable by a fine not to exceed \$100.00 on the first conviction, \$200.00 on the second conviction within one year, and \$500.00 on the third conviction within one year.

These regulations were enacted in 1984 to discourage the proliferation of outdoor vendors along many of the City's arterial streets, selling items such as rugs, flowers, fruits and vegetables, framed art prints, mirrors, and stuffed animals. Popular locations were active or vacant service stations and the parking area of other commercial properties. At the time, the City Council was concerned about traffic safety (drivers becoming distracted) and the visual blight caused by these vendors. Businesses within the City which occupy buildings, and pay rent, taxes, utilities, and other usual business costs also objected to the outdoor vendors who were getting a "free ride," negatively affecting those businesses which are an important part of the City's tax base.

Enforcement of these outdoor vending regulations is provided by the Finance Department's Revenue Division, Neighborhood Services Department code enforcement officers, and the Police Department where necessary, usually on a complaint basis. Enforcement is not a high priority, but is undertaken when staff resources permit.


The prohibition on outdoor vending from private property described in this report reflects the City Council's policy relating to outdoor vending from 1984, when the regulations were first enacted, to the present.





**7.07.072 Outdoor sales and displays
unlawful.**

It is unlawful to sell, attempt to sell, or
display for sale any merchandise, food or
drink on private property except from
within a fully enclosed building.

**7.07.073 Certain activities or businesses
excepted.**

The prohibition of Section 7.07.072
shall not apply to the following activities
or businesses, when conducted in a zone
where such sale or display is permitted as
a matter of right pursuant to the city's
comprehensive zoning ordinance (Ord.
No. 2550, fourth series, as amended):

- (a) Display of merchandise outside
a fully enclosed building, in
association with a business
where purchase of such
merchandise ordinarily takes
place within the building;
- (b) Automobile, boat, trailer,
camper, motorcycle and
construction equipment sales
and rentals;
- (c) Retail lumber yards;
- (d) Fruit and vegetable stands
possessing a valid special
permit from the City Planning
Commission and authorization
from the California Department
of Agriculture;
- (e) Horticultural nurseries;

(f) Vending machines, when located in
service stations, motels, and other
"drive-in" businesses;

(g) Gasoline pumps, oil racks and
accessory items when located
on pump islands;

(h) Christmas tree sales;

(i) Fireworks sales;

(j) Yard sales (maximum one per
calendar year not to exceed two
consecutive days);

(k) Sale of newspapers, books,
periodicals and other printed
material;

(l) Mobile health and veterinary
clinics;

(m) Fund-raising activities
conducted by organizations
exempted from the business
operations tax by Section
23.01.103(b) of the Sacramento
City Code.

(n) Flea markets.

7.07.074 Penalty for violation.

Any person violating Section 7.07.072
is guilty of an infraction subject to the
provisions of Government Code Section
36900(b). Any person violating Section
7.07.072 shall be deemed guilty of a
separate offense for each day, or portion
thereof, during which such violation
continues and shall be punishable
therefore as provided in this section.
