Motion was made by Mr. Genshlea that the inter-class transfers as requested by Mr. Jones and outlined below be approved:





REQUEST FOR RECONSIDERATION OF

FOREMAN I EXAMINATION:
Water Department

The request from Ray Jones,
Water Division Superintendent,

for a Foreman I examination, with eligibility limited to employees with experience with equipment at the Sacramento River Water Treatment Plant, was presented to the board at the last regular meeting, was again considered. Mr. Jones and William Rogers, Water Treatment Plant Supervisor, were present at the meeting and answered questions from board members relating to the necessity of establishing a special Foreman I vacancy at the plant.

After discussion, motion was made by Mr. Alexander that Mr. Jones' request be approved and the Personnel Officer instructed to prepare an examination announcement notice for Foreman I (Sacramento River Water Treatment Plant) accordingly. Motion was seconded by Mr. Erickson and carried by the following vote:

Nature of Work:

This is the first level of professional and legal work involving legal research, statutory interpretation, preparation of the more routine legal forms, participation in actions in the Municipal and Superior Courts involving violations of city ordinances and assisting the City Attorney and/or Assistant City Attorney in the preparation of civil cases. As assigned, the incumbent will undertake legal research and fact-finding, render opinions to other city departments on the more routine matters; prepare correspondence and answer routine inquiries from attorneys and other agencies.

Illustrative Examples of Work:

Participates in actions involving Municipal Code violations and assists in the preparation of civil cases.

Prepares the more routine forms of court pleadings, ordinances, resolutions, contracts, leases, options and permits.

Performs legal research and fact-finding studies.

Assists in the writing and revision of briefs before appellate courts and administrative boards.

Studies and interprets law, and renders opinions to other departments on the more routine matters.

Acts in advising capacity at meetings of the City boards and commissions, and advises city departments on legal matters.

Drafts complicated legal forms used in the formation of assessment districts, options, leases and contracts.

Meets and negotiates with outside parties in matters arising out of claims, property transactions, and other city business.

Knowledge, Abilities and Skills:

Thorough knowledge of legal research methods and ability to perform research.

Working knowledge of legal principles and their application, general law and court decisions with particular reference to municipal government functions.

Working knowledge of trial and hearing procedure and rules of evidence.

Ability to analyze and appraise facts and precedents.

Ability to present statements of fact, law, and argument clearly and logically in written and oral form.

Skill in preparing cases, securing necessary information and interviewing witnesses.

Ability to use correct English.

Ability to meet and deal effectively with persons contacted in the course of duties.

Desirable Experience and Training:

Education equivalent to completion of an approved law school, and at least one year of full time experience as an Attorney in the office of a City Attorney, County Counsel, State Attorney General, or comparable public legal department, or two years of full time experience in the general practice of law with experience before public bodies and administrative agencies.

Necessary Special Qualification:

Active membership in the State Bar of California for one year prior to appointment.

ZOO GATEKEEPER

Nature of Work:

This is routine work involved in the control of admission gates to the William Land Park Zoo. The incumbent works under the direct supervision of the Zoo Superintendent, and is responsible for admitting the public into the zoo grounds after payment of the required fees, or without charge in accordance with zoo regulations.

Illustrative Examples of Work:

Acting as guard at the William Land Park Zoo entrance gate, and admitting persons into the zoo grounds after payment of the required fee, or without charge in accordance with regulations.

Making change for zoo customers, and accounting for daily receipts with simple reporting at the conclusion of each day's activities.

Explaining zoo regulations and giving general information to the public about the zoo features.

Performing other related work as required.

Knowledges, Skills, and Abilities:

Ability to handle the public courteously.

Ability to understand and follow written and oral instructions.

Ability to make change rapidly and accurately.

Ability to keep simple records correctly.

Desirable Experience and Training:

Some experience in work which involves public contact, and education equivalent to graduation from high school.

Zoo Gatekeeper


Secretary advised that a new


