Adopt a Resolution: 1) approving plans and specifications; 2) accepting the low bid of Martin General Engineering, Inc. in the amount of \$328,148; and 3) authorizing the City Manager to execute a contract in the amount of \$328,148 with Martin General Engineering, Inc.

**Summary:**

This project will reconstruct existing pavement and construct new curb, gutter, sidewalk, storm drains, water main, and street lights.

**Background Information:**

This project was advertised and bids were received on January 25, 2006. The bids are summarized below:

Martin General Engineering, Inc.	\$328,148.00	91.6%
Vintage Paving Company, Inc.	\$331,907.60	92.5%
Granite Construction Company	\$371,522.00	21.7%
C & C Construction, Inc.	\$422,937.00	26.9%
Vanguard Construction	\$474,150.00	19.6%

The engineer's estimated construction cost was \$312,220.

It is recommended that the contract be awarded to Martin General Engineering, Inc. for its lowest responsive and responsible bid.

Construction is expected to begin in April 2006 and be completed in August 2006.

**Financial Considerations:**

The current project budget is \$500,430. The estimated total project cost, including all planning, design, construction, and construction engineering cost is \$481,762. As of February 3, 2006, the unobligated balance is \$445,890 which is sufficient to execute the contract in the amount of \$328,148 with Martin General Engineering, Inc. and cover remaining project management and construction engineering costs.

**Environmental Considerations:**


The Development Services Department, Environmental Planning Services Division has reviewed the proposed action and determined that the project is exempt from the provisions of the California Environmental Quality Act (CEQA) under Class 1, Section 15301(c) and Class 2, Section 15302(c) of the CEQA Guidelines. Class 1, Section 15301(c) consists of the replacement, repair or minor alteration of existing streets and highways, including road grading for the purpose of public safety and Class 2, Section 15302 (c) consists of the replacement or reconstruction of existing utility systems and/or facilities involving negligible or no expansion of capacity.


**Policy Considerations:**

The action requested herein is consistent with the City's Strategic Plan to achieve sustainability and enhance livability.

**Emerging Small Business Development (ESBD):**

The ESBD goal is 20%. To encourage small and emerging business participation, plans and specifications were sent to 16 plan rooms and construction service organizations for publication. All are directly involved with E/SBE construction firms. The project was also announced on the City's Internet site at [www.cityofsacramento.org/bids](http://www.cityofsacramento.org/bids). Martin General Engineering, Inc. has achieved 91.6% ESBD participation.

- C. Construction is expected to begin in April 2006 and be completed in August 2006.

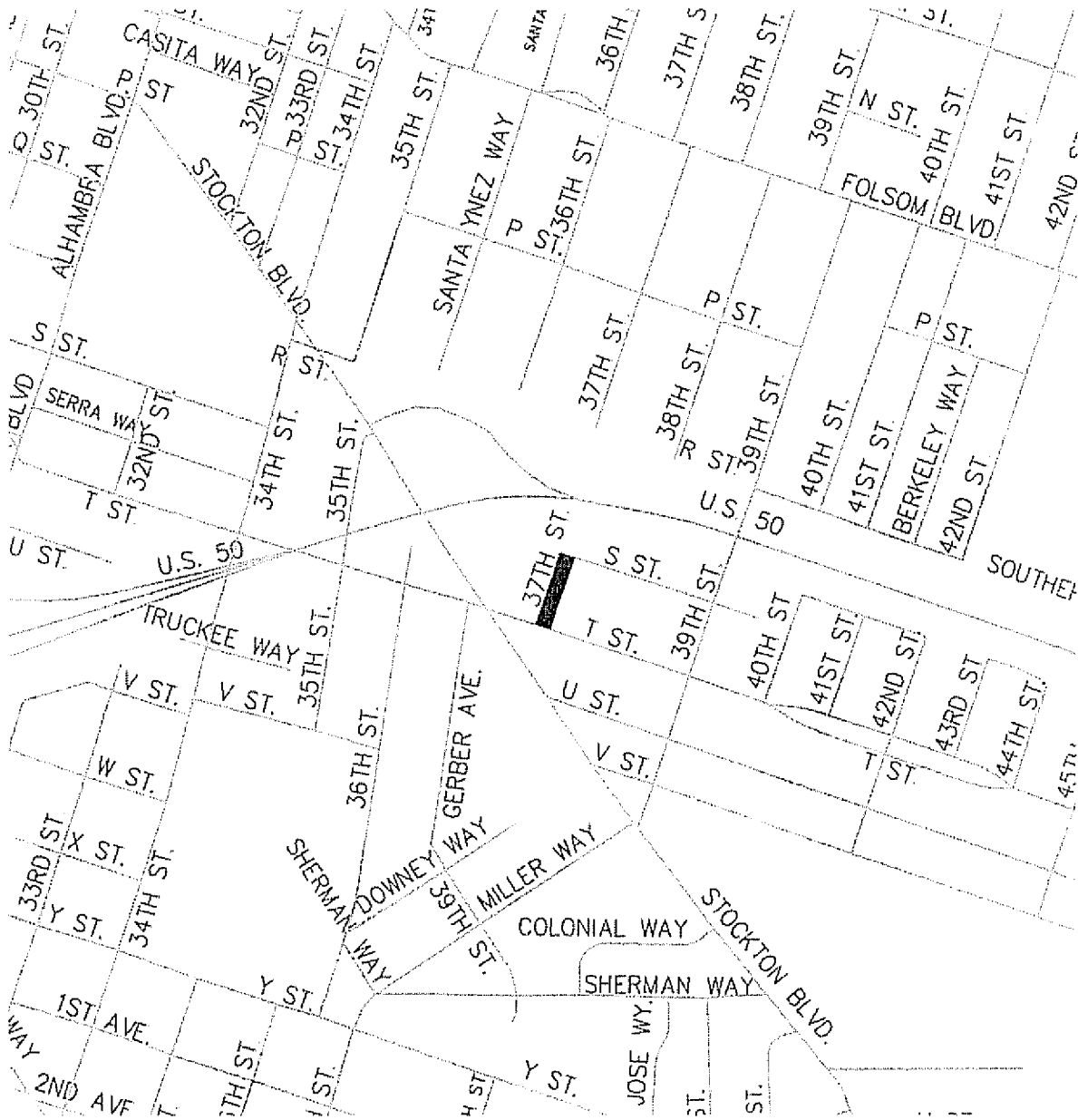
**BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:**
