SUBJECT: Matters related to the Acquisition with Rehabilitation Program (CA30-P005-035).

SUMMARY

This report requests authorization for the Executive Director to perform the following items related to the Acquisition with Rehabilitation Program (CA30-P005-035): (1) Upon the approval by the Department of Housing and Urban Development (HUD) advertise all units for bid; (2) Enter into construction contracts with the lowest responsible bidder for the rehabilitation of the units; and (3) Execute change orders to an accumulative value not to exceed 15% of the original bid amount.

BACKGROUND

On May 20, 1988 the Housing Authority was invited by HUD to submit an application for Low Income Housing under the Acquisition with Rehabilitation Program. The program is designed to allow us to purchase one to 12 unit structures on scattered sites anywhere within the incorporated area, and complete the required rehabilitation prior to entering the units to the existing housing inventory. Tenants pay no more than 30 percent of their income for rent.

On December 18, 1989, HUD notified the Authority of its approval to acquire and rehabilitate 50 units.

As of December 20, 1990, with your permission, the Authority has purchased 23 units, and optioned an additional 7 units. We are actively seeking the other 20 which will provide us a cushion if any unit is not approved by HUD.

In order to proceed with the program and begin the rehabilitation process, staff is requesting the Executive Director be given the authority to, (1) advertise all units for bid (2) enter into construction contracts with the lowest responsible bidder for rehabilitation of the units; (3) execute change orders to an accumulative value not to exceed 15% of the original bid amount.

FINANCIAL DATA

The total Development Cost Budget for the project is \$4,562,500 or \$91,250 per unit.

POLICY IMPLICATIONS

The actions proposed in this staff report are consistent with previously approved policy.

ENVIRONMENTAL REVIEW

CEQA: The proposed action is exempt from environmental review per CEQA Guidelines, Section 15301 Class 1. HUD performs all necessary federal environmental reviews.

MBE/WBE EFFORTS

Minority and women contractors will be encouraged to bid on the rehabilitation projects funded under this program. All HUD and Agency MBE/WBE requirements will be adhered to in the advertising and awarding of bids.



AUTHORIZATION TO SOLICIT BIDS AND CONTRACT FOR REHABILITATION OF ACQUIRED HOUSING UNITS

BE IT RESOLVED BY THE SACRAMENTO HOUSING AND REDEVELOPMENT COMMISSION:

Section 1: The Executive Director is hereby authorized to perform the following actions relating to housing units now or hereinafter acquired under the Department of Housing and Urban Development (HUD) Acquisition and Rehabilitation Program CA30-P005-035:

- (a) Upon HUD approval, solicit bids for performance of rehabilitation work;
- (b) Enter into contracts with the lowest responsible bidders for performance of rehabilitation work; and
- (c) Execute change orders under such contracts as may be necessary, provided that the aggregate dollar amount of all change orders under any single contract shall not exceed fifteen percent of the original contract amount.
