The Civil Service Board met in regular session at 7:30 P.M.

PRESENT: Commissioner Deise and Wright

Minutes of the previous meeting were approved as read.

RADIO TECHNICIAN - PREVAILING RATE

Mr. Gilbert De La Iaing, Assistant Business Manager of the Radio and Television Engineers Local

No. 202, appeared before the Board to discuss the request of the Union to establish the prevailing rate paid to Radio Technicians employed by the City of Sacramento on the basis of the contract with Radio Station KFBK, rather than on the basis of the contract with Radio Stations KGMS, KROY and KXOA. Earl Simons, Personnel Technician II who prepared the report recommending that this request be denied, was also present to explain the methods used in preparing the report and the reasons for the finding.

After considerable discussion, it was properly moved and passed that the matter be held over to a subsequent meeting of the Board, and that in the meantime the Secretary should prepare a survey of rates paid for Radio Technicians in other agencies and utilities. Mr. De La Iaing was requested to prepare a technical report for the Board, comparing the technical duties of Radio Technicians employed by the City and Radio Technicians employed by Local Radio Stations.
