
## BACKGROUND INFORMATION

The Council awarded a contract to Teichert Construction on April 24th, 1979 for constructing concrete curbs, gutters and sidewalks, asphaltic concrete pavement, storm sewers, drainage facilities and a street lighting system complete in the above named Assessment District. At the time of signing the contract, the completion date was scheduled for February 1st, 1980, however, the work will not be finished by that time due to a delay in delivery of electrical materials.

## RECOMMENDATION

It is recommended therefore, that the Council grant an extension of ninety days to Teichert Construction by adoption of the attached Resolution Extending Time On Contract.
