SUMMARY

Adoption of Resolution Amending Resolution Directing City Clerk to Advertise For Bids.

BACKGROUND INFORMATION

On May 8th, 1980, the City Council adopted the Resolution Directing the City Clerk to advertise for Bids for Del Paso Heights Assessment District No. 4A, which set the bid date for May 27th, 1980. This date is in conflict with the bid date published in the newspaper and the date stated in the specifications for this project which stated bids would be received on June 3rd, 1980.

Edgar Boyles, Jr., Bond Counsel for the City, has recommended that the Resolution be amended to read bids to be received on June 3rd, 1980, rather than May 27th, 1980, thus saving the cost of republishing and delay that would be caused by the re-noticing of the public.

FINANCIAL DATA

No additional cost would be incurred by the City by this action.

RECOMMENDATION

It is recommended that the attached Resolution be adopted which changes the bid date from May 27th, 1980 to June 3rd, 1980.
