

MINUTES OF CIVIL SERVICE BOARD
CITY OF SACRAMENTO
SPECIAL MEETING.

October 15, 16, 17, 22, 1935.

The Civil Service Board met in special session in the office of the Board for the purpose of holding Junior Clerk Examination Personal Interviews at 6:50 P.M., President Deise presiding.

PRESENT: Commissioners Chenu, Stacy, President Deise.
ABSENT: None.

MATRANGA, VINCENT V.
LABORER'S EXAMINATION

Mr. Matranga appeared at the meeting requesting information relating to his failure to receive a passing grade in the Laborer's examination. Board members explained to Mr. Matranga that a percentage of seventy must be attained and inasmuch as his grade was less than seventy he had not passed.

LOUIS, JACK
LABORER'S EXAMINATION

Mr. Lewis appeared at the meeting stating that he was on the previous Laborer's Eligible Register, that he had elected to be placed upon the new Register at the grade attained upon the previous register and asked the Board if his name could not be placed higher upon the new list due to his having had approximately four months work with the city from the old list. Board members explained to him that the only way his position could be changed was for him to have taken the new examination, which he did not elect to do, hence the Rules required that his name be placed upon the new register in accordance with the percentage received at the previous examination.

LANTERI, JOHN J.
PATROLMAN'S EXAMINATION

Mr. Lanteri appeared in the office

October 12, 1935, requesting permission to take the athletic and physical portions of the Patrolman's examination at a later date and to continue with the examination, stating that he had been absent from the city upon duties connected with the Sheriff's office.
