

RESOLUTION OF COMMENDATION (CONT'D)

WHEREAS, Bartley W. Cavanaugh was appointed to the Civil Service Board on October 14, 1937, and served with distinction as a member of the Board until his appointment as City Manager on June 1st, 1946;

NOW, THEREFORE, BE IT RESOLVED that the Civil Service Board of the City of Sacramento does hereby express regret at the loss of an administrator of the calibre of Bartley W. Cavanaugh, while at the same time sharing his hopes for a long and happy period of well-earned retirement."

DISCUSSION OF SALARY RECOMMENDATIONS:

The Board discussed the recommendations made by the Personnel Officer for salary adjustments and compensation plan changes and the comments relating thereto made by representatives of the Firefighters' Union and Sacramento City Employees' Association.

Various alternatives were considered and after considerable discussion, a motion was made by Mr. Erickson that the Civil Service Board recommend an appropriation of \$325,000 in the 1964-65 budget to provide for salary adjustments effective January 1, 1965 with recommendations for specific adjustments for the various classes to be withheld until not later than December 1, 1964, in order to give the Board an opportunity to make additional studies and to consider various salary changes generally made by other governmental agencies between July 1 and December 31, changes in local prevailing salary levels, and the most up-to-date information relating to wage changes in private employment throughout the state. The motion died for a lack of a second.

After further discussion, the Chairman advised that a special meeting would be held on Thursday, May 7, 1964, at 8:30 p.m. for further consideration of salary recommendations.
