SUBJECT: Metropolitan Arts Division -  
Sacramento County Cultural Awards Contract

SUMMARY

This report recommends approval of a contract for administration of the Sacramento County Cultural Awards Program between the City and the County of Sacramento. It also recommends that the FY88/89 Sacramento Metropolitan Arts Commission's operating budget be amended to include the full \$25,000 being awarded. This includes an increase of \$8,900 above the \$16,100 already approved during the City's budget process for FY88/89.

BACKGROUND

On September 20, 1988, the County Board of Supervisors approved a resolution appropriating \$25,000 to the Sacramento Metropolitan Arts Commission to cover costs of administering the Sacramento County Cultural Awards Program. This program provides support to local arts organizations through a regranting process. The Arts Commission has administered the program since 1979.

FINANCIAL DATA

Funding for the Sacramento County Cultural Awards Program and its administration costs of \$25,000 are provided by the County of Sacramento. No additional funds are required.

RECOMMENDATION


