



**SUBJECT: Annual Contract with Greater Sacramento Area Plan (GSAP)  
Organization**

**SUMMARY**

The attached resolution authorizes the Executive Director to execute an Agreement with the Greater Sacramento Area Plan (GSAP), a non profit organization, to provide support to contractors' affirmative action programs and requests a budget amendment to fund the contract.

**BACKGROUND**

In 1974, the Sacramento Housing and Redevelopment Agency (SHRA) adopted a policy requiring affirmative action in Agency construction and public works contracts. To further the governing bodies and Agency's commitment to equal opportunity, the Agency has since 1978 annually contracted with GSAP to help implement this policy. From 1978 to June 1989 GSAP staff performed affirmative action record keeping on Agency projects as well as prevailing wage field compliance monitoring. In June 1989, the County Board of Supervisors adopted a policy which restructured GSAP and provided for four GSAP staff members to transfer to County employment. The affirmative action record keeping functions became the responsibility of the County. SHRA immediately contracted with the County for one labor compliance field person to assume the field responsibilities for Agency projects previously performed by GSAP. The labor compliance field person under annual contract from the County is a former GSAP employee. GSAP currently focuses on supporting pre-apprenticeship programs to insure the entry of

qualified minorities and women into the construction trades and to aid contractors in complying with affirmative action goals in public works projects. Since the ordinance adoption in June 1989, GSAP has operated with an interim budget which expires in June 1990. Staff proposes 1) renewing the contract with GSAP for services; and 2) allocating SHRA's share of funding for GSAP's operations.

## **FINANCIAL DATA**

GSAP's Board of Directors have approved a budget for their fiscal year July 1, 1990 through June 30, 1991. GSAP receives funding jointly from the City, County and SHRA. SHRA proposes to commit its share of GSAP funding, a total of \$16,600, for the six months of Agency's budget year, July 1, 1990 through December 31, 1990. (The Agency will include the next six months of GSAP's fiscal year funding in the Agency 1991 budget).

## **MBE/WBE REVIEW**

## **ENVIRONMENTAL REVIEW**

The proposed action is exempt from environmental review per CEQA guidelines, Section 15378 (b)(3) and NEPA per 24 CFR Part 58.34 (a)(3).

## **POLICY IMPLICATIONS**

The action proposed in this report is consistent with previously approved policy.


