

**RESOLUTION NO. 2006-641**

Adopted by the Sacramento City Council

August 29, 2006

**STOCKTON BOULEVARD BEAUTIFICATION – PHASE III  
PROJECT (PN: TY51)**

**BACKGROUND**

- A. The Stockton Boulevard Beautification – Phase III Project will construct aesthetic improvements and enhance bicycle and pedestrian safety along Stockton Boulevard between El Paraiso Avenue and Riza Avenue. The improvements include landscaped medians, bike lanes, new curb, gutter and sidewalk in various areas, tree wells, new curb ramps, new drain inlets, traffic signal modifications, and dual left turn lanes at 47<sup>th</sup> Avenue and Stockton Boulevard in all four directions of travel.
- B. This project was advertised and bids were received on July 18, 2006. The bids are summarized below:

The engineer's estimate is \$3,000,000.

- C. Construction is expected to begin in September 2006 and be completed in December 2006.

**BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL  
RESOLVES AS FOLLOWS:**

- Section 1. The contract plans and specifications for the Stockton Boulevard Beautification – Phase III Project (PN: TY51) are approved, and the contract is awarded to Martin Brothers Construction for an amount not to exceed \$2,899,090.
- Section 2. The City Manager is authorized to execute the contract on behalf of the City.

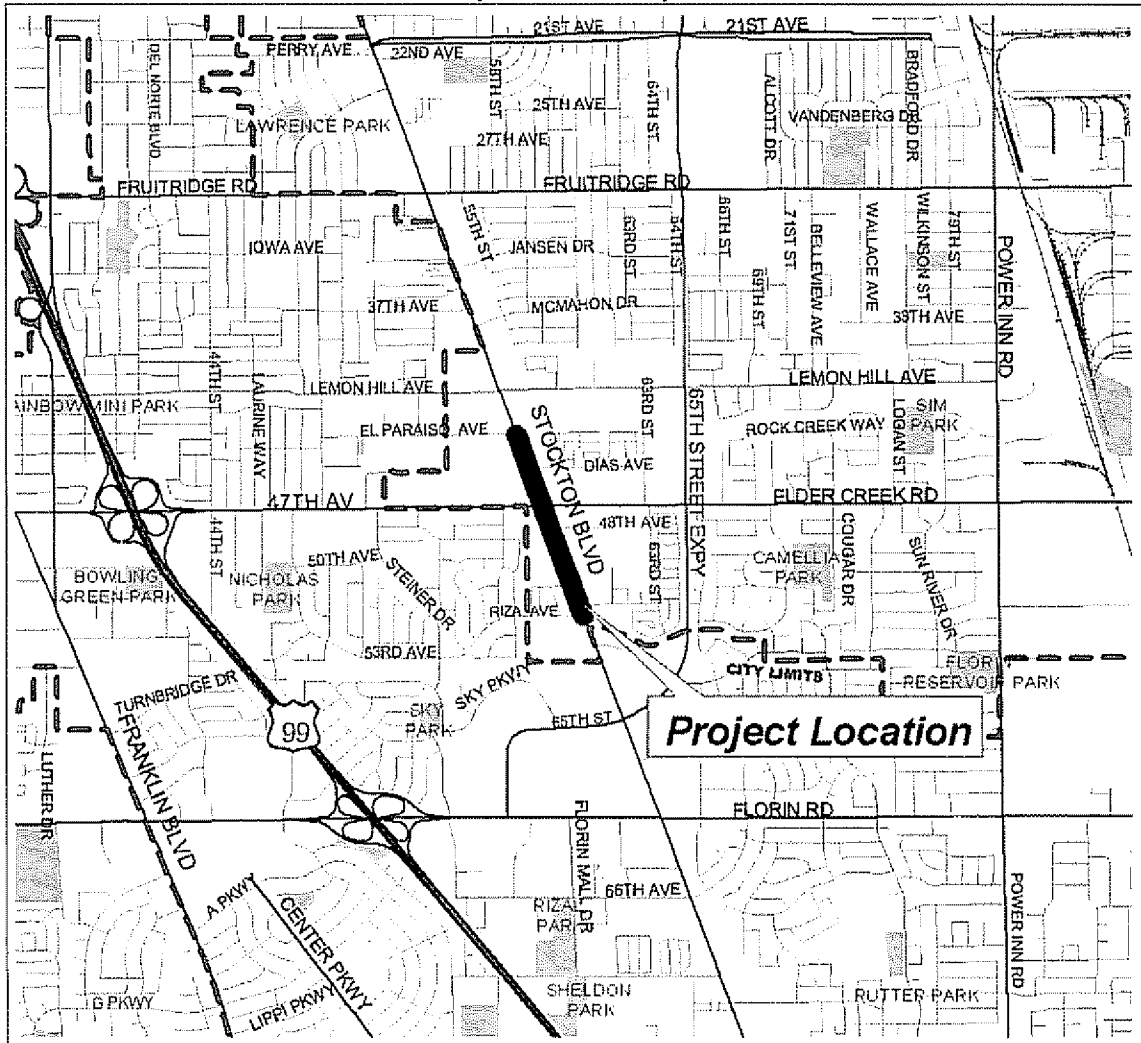
