## SUMMARY

The attached resolution authorizes the Executive Director to amend the Agency budget to incorporate projected revenues and expenditures for Annual Contributions Contract (ACC) Number CA30-V005-013.

## BACKGROUND

On June 15, 1989, the Agency submitted an application to the U.S. Department of Housing and Urban Development (HUD) for 25 Section 8 Housing Vouchers.

On August 16, 1989, the Agency received notification that the application was approved for twenty-five (25) Vouchers. The authorized unit distribution was for five (5) one-bedroom and twenty (20) two-bedroom Vouchers.

On August 30, 1989, the new Voucher ACC for Project Number CA30-V005-013 was executed.

Approval of the attached resolution will authorize the Executive Director to complete the required actions to add this new allocation of housing assistance to our Section 8 inventory, and to amend the Agency Budget accordingly.

## FINANCIAL DATA

1. ACC authority has been reserved in the amount of \$128,710. The 1989 Agency Budget will be amended to reflect additional revenues that will be generated from the execution of this ACC. Those revenues will be as follows:

Housing Assistance Payments	\$ 9,354
Preliminary Fees (rent-up fees for first year only)	\$ 6,875
Ongoing Administrative Fees	\$ 1,617
Total Projected Revenues	\$17,846

2. The 1989 Agency Budget will be amended to reflect additional expenditures that will be incurred from the execution of this ACC. Expenditures will be distributed as follows:

<u>Total ACC</u>	<u>Non-Departmental HAPs</u>	<u>Leased Housing</u>	<u>Tenant Selection</u>	<u>ACC Balance*</u>
\$128,710	\$9,354	\$5,054	\$3,438	\$110,864

\* ACC Balance amount is the unexpended portion of available funding. This amount will be applied in the 1990 Budget.
