**Subject:** Repeal of Interim Ordinance related to Superstores (M04-081)

1) Review the attached Ordinance repealing Interim Ordinance No. 2005-013 related to superstores; 2) Pass for publication the Ordinance title as required by Sacramento City Charter 32c; and 3) Continue to May 16, 2006 for adoption.

**Summary:**

On February 15, 2005, the Sacramento City Council adopted an interim ordinance requiring a special permit for superstores in the City of Sacramento (Ordinance No. 2005-013). The permanent ordinance amending Title 17 of the Sacramento City Code was adopted by the Sacramento City Council on April 18, 2006 (Ordinance No. 2006-027), thereby making the interim "stand alone" ordinance unnecessary. The attached ordinance repeals the interim ordinance adopted by the City Council in 2005.

**Committee/Commission Action:**

On January 5, 2006 the Law and Legislation Committee recommended that the proposed amendments to Title 17 of the City Code related to superstores be reviewed by the Planning Commission and forwarded to City Council. On February 23, 2006, by a vote of seven ayes, one no and one vacant, the Sacramento City Planning Commission voted to recommend approval of the proposed amendments and forward to City Council. On April 18, 2006, by a vote of eight ayes and one abstension, the City Council adopted the ordinance amending Title 17 of the City Code requiring a special permit for superstores.


The proposed amendment to the City Code is exempt under CEQA Section 15061(b) (3).

**AN ORDINANCE REPEALING ORDINANCE NO. 2005-013,  
AN INTERIM ORDINANCE RELATING TO SPECIAL PERMITS  
FOR SUPERSTORES (M04-081)**

BE IT ENACTED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

SECTION 1. On April 18, 2006, the Council enacted Ordinance No. 2006-027 amending Title 17 of the Sacramento City Code (the Zoning Code) establishing a special permit requirement for superstores.

SECTION 2. Ordinance No. 2005-013, an interim ordinance relating to special permits for superstores, is repealed.
