SUBJECT: REPORT BACK – TRAFFIC SIGNALS – AZEVEDO DRIVE AND BANNON CREEK DRIVE

SUMMARY

At the May 1, 1990, Joint Committee meeting, Councilmember Heather Fargo requested staff to come back with a report on traffic signals for Azevedo Drive and Bannon Creek Drive.

BACKGROUND

On a yearly basis, the Public Works Department develops a priority list for the installation of traffic signals in the City of Sacramento. The prioritization of locations for traffic signal installations are based on: the amount of traffic carried on the major street, as well as the minor street; past accident experience; pedestrian crossing volumes; street speeds; plus other factors which determine need. Approximately 80 to 100 traffic signals are reviewed each year, and then the staff recommends installation of three to five traffic signals based on this prioritization process and the availability of funding.

Under the above criteria, traffic signals that primarily service pedestrian/school activity do not receive high enough point values to place them in the top priority positions. In light of this factor and current problems the City is facing at several pedestrian crossing areas, staff will develop a separate prioritization list to identify pedestrian/school signals on a Citywide basis. When this list is completed, the Public Works Department will bring it back to the Council for review and approval. Staff anticipates that this new prioritization list and a Council report will be ready for presentation in approximately four months. Until this new list is presented to the Council, staff recommends that no new signals be added to the proposed 1990/91 CIP.



RECOMMENDATION




