### Description/Analysis

**Issue:** Street Services Division, Traffic Signals and Lighting section has an ongoing need for night street re-lamping. The current supplemental agreement expires June 30, 2007.

**Policy Considerations:** The Equal Benefits Ordinance (EBO) and Living Wage Ordinance is applicable to this agreement and the contractor has signed the Declarations of Compliance. The recommendations in this report are consistent with the City's Strategic Plan goals to improve and expand public safety, and achieve sustainability and livability.

**Commission/Committee Action:** None


**Rationale for Recommendation:** The Street Services Division, Signals and Lighting section, has a nonprofessional services agreement with Jackson Electric for Maintenance of Street Lighting (re-lamping). Due to the continued need for


**Emerging Small Business Development (ESBD):** Jackson Electric is certified with the City as an emerging and small business enterprise.



**Background**

The Street Services Division, Signals and Lighting section, has a nonprofessional services agreement for Maintenance of Street Lighting (re-lamping) with Jackson Electric. It was advertised, bid and awarded in June 2005 for a not-to-exceed amount of \$72,528. The first supplemental agreement for an annual extension for \$73,980 was approved by Council in June 2006 and expires June 30, 2007. The approval of this supplemental agreement will bring the total 3-year expenditure under the agreement to \$222,780.

Staff anticipates a continued need for this night re-lamping service for this next fiscal year and future years as well. In exhibit A, section 4 of the agreement, there is an option to extend on a year-to-year basis, through June 30, 2010 with annual cost adjustments based on the Consumer Price Index (CPI), not to exceed five per cent.

**APPROVE SUPPLEMENTAL AGREEMENT FOR MAINTENANCE OF STREET LIGHTING**

**BACKGROUND**

- A. The Street Services Division, Signals and Lighting section, has a nonprofessional services agreement for Maintenance of Street Lighting (re-lamping) with Jackson Electric. It was advertised, bid and awarded in June 2005 for the amount of \$72,258.
- B. In Exhibit A, section 4 of the agreement, there is an option to extend on a year-to-year basis, through June 30, 2010 with annual cost adjustments based one the Consumer Price Index (CPI), not to exceed five percent.
- C. The first supplemental agreement for an annual extension for \$73,980 was approved by Council in June 2006 and expires June 30, 2007. Approval of this supplemental agreement will bring the total 3-year expenditure under the agreement to \$222,780.

**BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:**

- Section 1. The City Manager is authorized to execute the supplemental agreement for the annual extension of the nonprofessional services agreement (CM2005-0723) with Jackson Electric for an amount not to exceed \$76,272.
