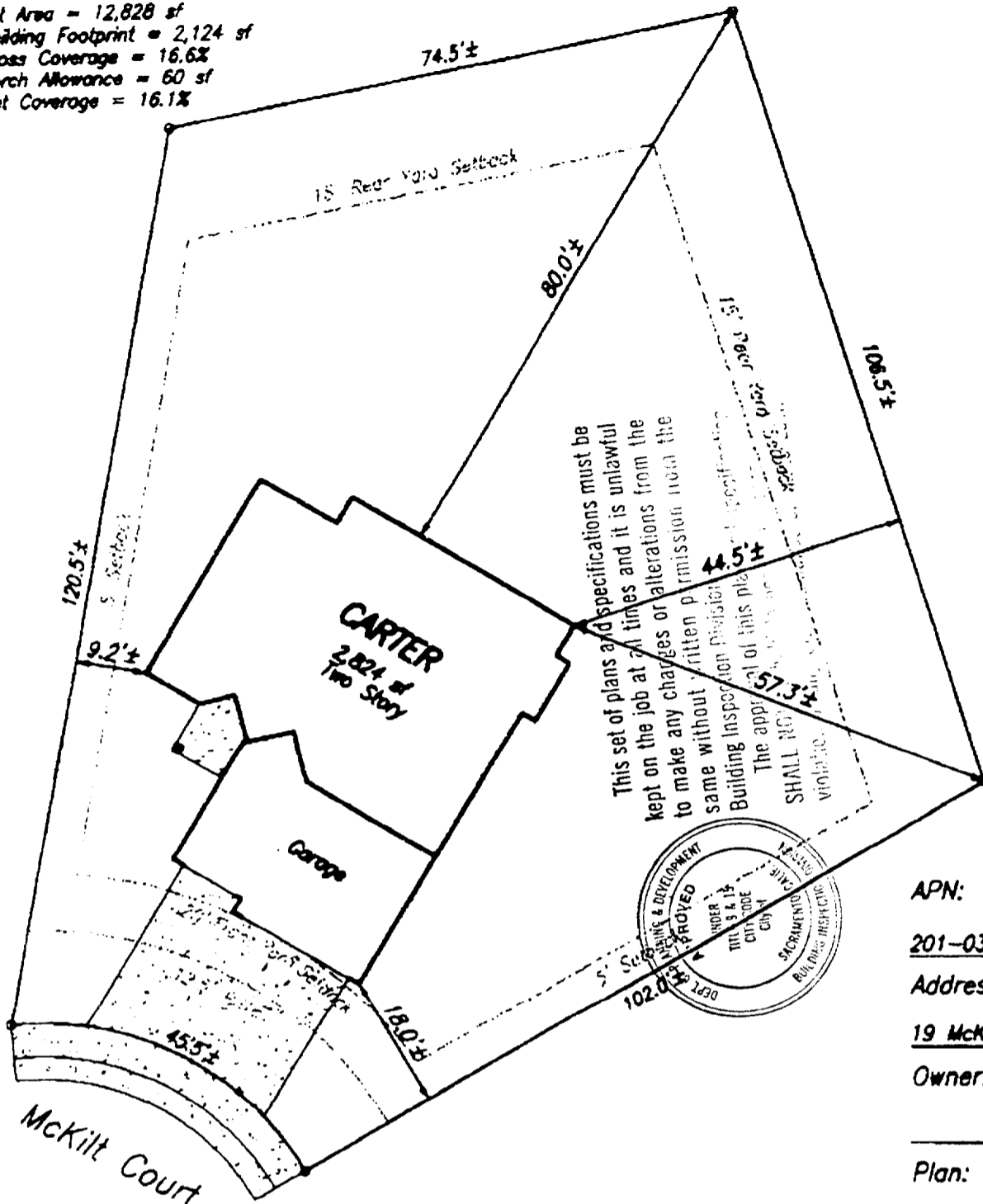


Plot Plan for Lot 62 for Northborough Village 6-1

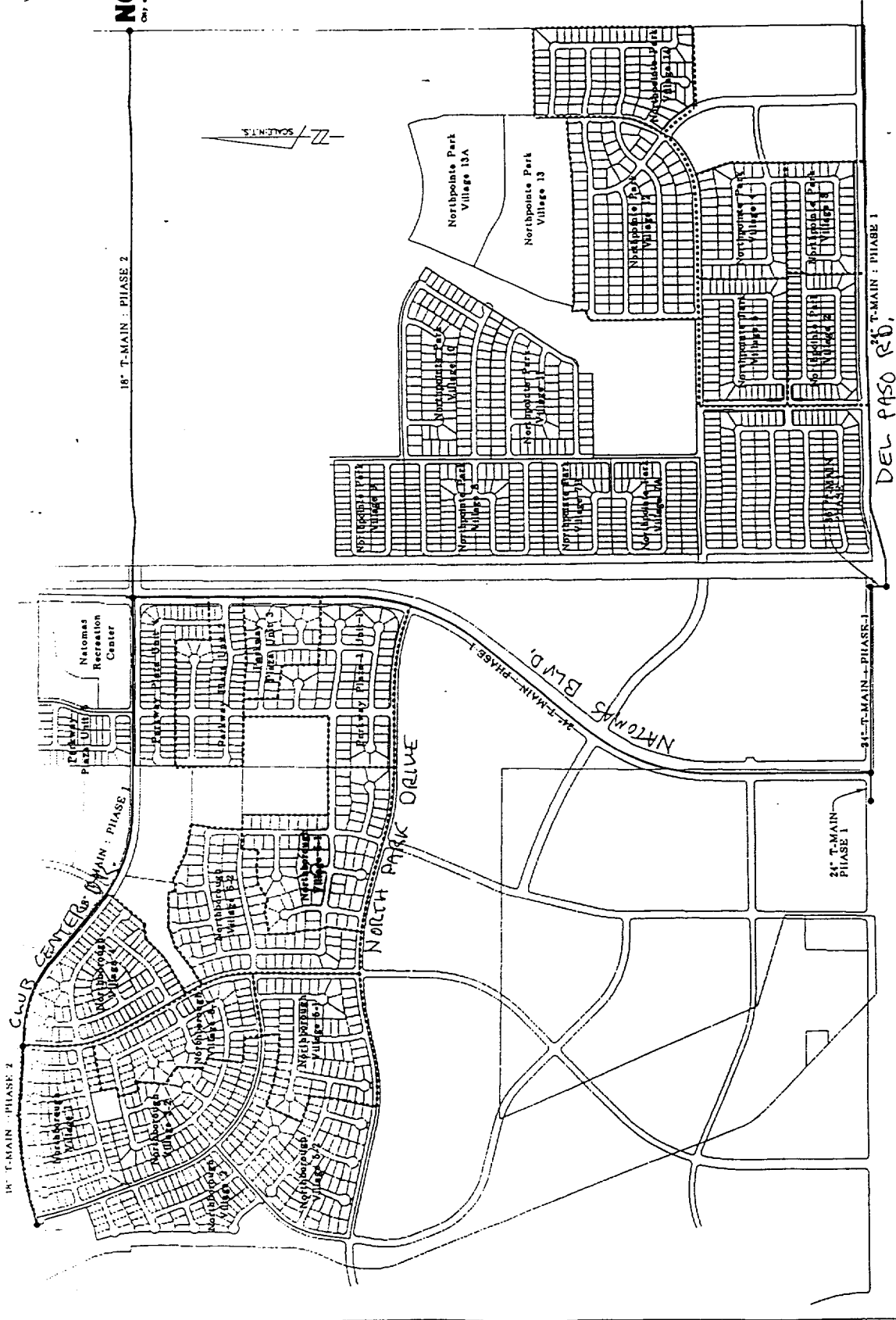
