

RESOLUTION NO. 1301

Adopted by the Housing Authority of the City of Sacramento

January 16, 1975

AWARDING GENERAL CONSTRUCTION CONTRACT
PROJECT CAL 5-18

WHEREAS, the following has occurred:

1. Mau, Barnum, Folson & Mirza, Architects, employed as such by the Housing Authority of the City of Sacramento did, as of December 17, 1974, prepare plans and specifications to complete the construction of Project CAL 5-18, Housing Project owned by the Housing Authority of the City of Sacramento.

2. In accordance with the requirements of the Housing Authority and other requirements of law, an Invitation for Bids for such construction work was duly and regularly advertised in a newspaper of general circulation on November 4 and 11, 1974.


3. On December 17, 1974, pursuant to said Invitation for Bids, eight bids were opened and received as attached; and

WHEREAS, of the eight bids opened and received, the lowest bidder was:

A. L. BENDER, INC. \$988,179.00.


NOW, THEREFORE, BE IT RESOLVED BY THE HOUSING AUTHORITY OF THE CITY OF SACRAMENTO:

Section 1. The bid of A. L. BENDER, INC. to furnish all labor, material, equipment and services and to complete all of the work required, as specified in said contract, in the sum of NINE HUNDRED EIGHTY-EIGHT THOUSAND ONE HUNDRED SEVENTY-NINE and NO/100 DOLLARS (\$988,179.00) is hereby accepted, and the contract for performance of all such labor, material, equipment and services for such work is hereby awarded to A. L. BENDER, INC.; subject, however, to the approval of the Department of Housing and Urban Development.
