11.0 STAFF REPORTS

- 11.1 Update on Graffiti Ordinance and abatement efforts. (D-All) [oral report by Noel Eusebio]

Noel Eusebio, Anti-Graffiti Program Coordinator, gave a background of the program. He said it was initiated through the City Manager's Office in 1989. The "graffiti busters program" was created in the former Parks & Community Services department, which hired 16 teen with rotating weekend crews to remove graffiti. Due to budget reductions, the program was eliminated in June, 1993.

In November, 1993, at Council's direction, a renewed emphasis on fighting graffiti was initiated and resulted in the following efforts: in the Neighborhood Services department an anti-graffiti program was re-instated to include six youth aides and a supervisor. This program was to eliminate graffiti gang signs and visual blight, provide meaningful youth employment, establish information/education resources for the community and establish a volunteer work pool for neighborhood graffiti abatement.

Mr. Eusebion said the Public Works department pilot anti-graffiti effort was approved by the City Council in January, 1995 and included a full-time painter and a special vehicle with anti-graffiti equipment and a computerized paint analyzing system to match paint in the field, working with local paint companies and recycle paint manufacturers to develop standard colors for graffiti abatement, and training for other city staff on the proper methods to remove graffiti.

Mayor Serna asked about the funding of the program. Ms. Eusebion replied that it was funded through the General fund and the landscaping and Lighting Assessment District at a cost of about \$135,000 a year.

This information was received and filed.

11.2 Neighborhood Accountability Boards. (D-All) [Chief Venegas]

Arturo Venegas, Chief of Police described the program to the Council. He said it would be a community-based juvenile justice system whereby justice would be quicker and more visible in the same neighborhoods where offenses occurred.

The Chief said the proposal was based on a similar program in San Bernardino County. It would be administered by the Probation Department, and would bring community resources to bear on the problem. He said staff had started working out the details of the program. During the curfew sweeps performed in targeted neighborhoods, the department involved neighborhood associations and parents, and offenders were assigned community work.

Mayor Serna inquired if the City had statutory authority for this program; the Chief replied yes, it did.

Mr. Serna asked when staff would return to Council with the final program; the Chief responded in a few months.

Council members Cohn, Steinberg and Fargo voiced their support of the program.

Christine Silva inquired about who would sit on the board.

Chief Venegas replied that details had not been worked out yet, and recommended that she contact him if she were interested.

This information was received and filed.

11.3 Small Business Report. (D-All) [Dean Peckham]

Dean Peckam, Management Analyst, stated that the current City Council adopted its first economic agenda for the City in November, 1993. Two of the top priorities identified were economic development and neighborhood revitalization and improvement. The Council had maintained this focus for the past 2 1/2 years.

Mr. Peckam said one of the key initiatives of the economic development agenda was to support existing businesses. He cited examples of activities within District 3 to support existing businesses to include: monthly meetings of the Police department, neighborhood businesses and

churches to address public safety issues; an NPO from the CSUS campus police serving the East Sacramento, River Park, and Campus Commons neighborhoods; NPO's working with the Midtown businesses to establish a Business Watch program; City Transportation's work on the Midtown Neighborhood Preservation Transportation Plan.

Mr. Peckam also discussed the Office of Economic Development's work with the Area Managers to develop a work program which addresses smaller business and neighborhood issues.

This information was received and filed.

11.4 Friends of McKinley Library. (D-All) [oral report by Dick Killian]

Dick Killian, Library Director, discussed the reopening of the McKinley Library and introduced the branch librarian, Sharon Nicolini.

Ben Krenshaw spoke about the McKinley Library, its programs and long-term goals to include access to the Internet and additional terminals. He invited the public to become involved, and said the next meeting of the McKinley Library affiliates would take place at the library at 7:00 p.m. on May 14, 1996.




