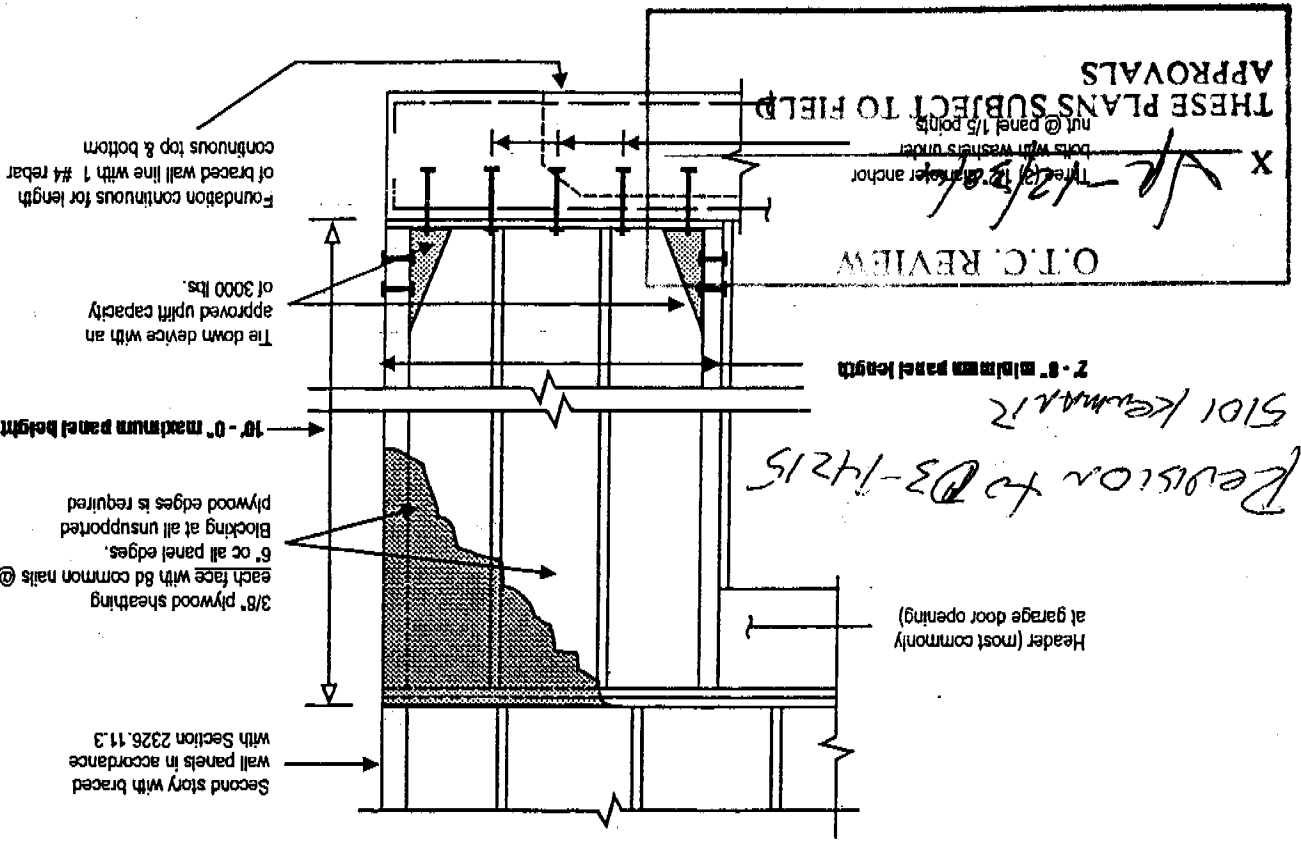

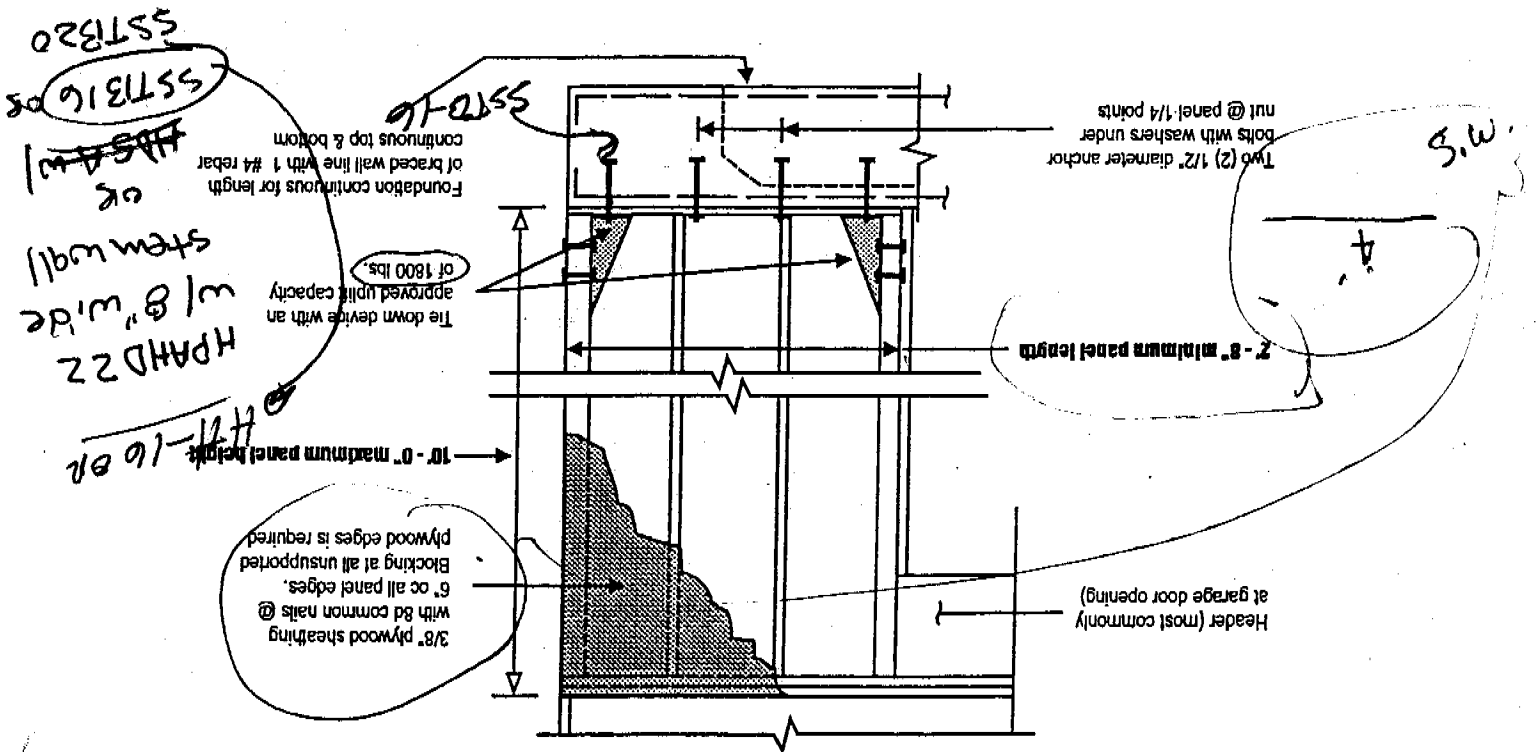

**ALTERNATE BRACED WALL PANEL AT FIRST STORY OF A TWO STORY BUILDING**

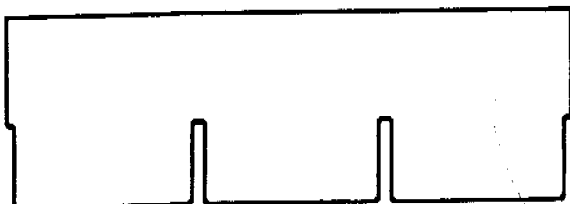


**\* ALTERNATE BRACED WALL PANEL AT ONE STORY BUILDING**

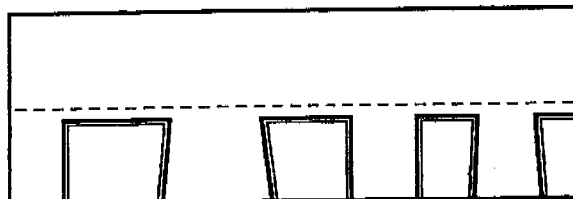

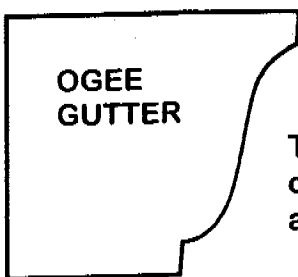


Three-tab NOT ALLOWED  
in Design Review Areas



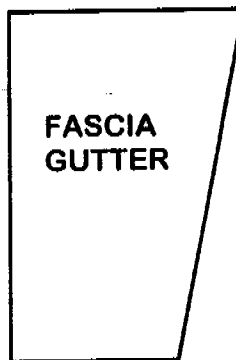

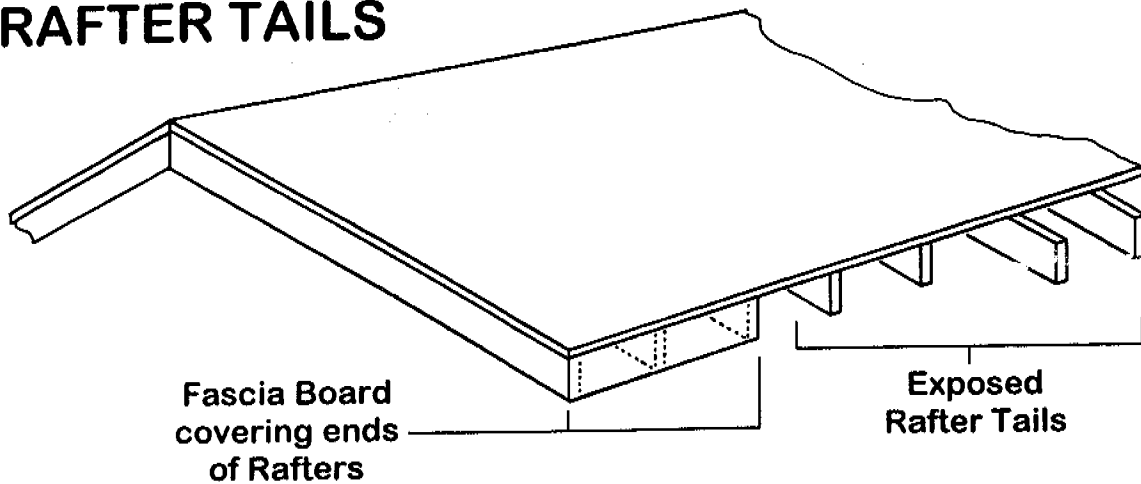
