SUBJECT: Appeal of Robert P. Roberson from the decision of the Chief of Police denying an Amusement Arcade Permit

SUMMARY

Attached is the appeal of Robert P. Roberson from the decision of the Chief of Police denying an application for an Amusement Arcade permit for property located at Round Table Pizza, 982 Florin Road, as required by Sacramento City Code Section 5.74.

BACKGROUND

Under Sections 2.323 and 2.324 of the City Code, the Council may appoint a hearing examiner to hear the appeal if it finds that "the appeal may involve a lengthy factfinding process which would be more appropriately accommodated by a formal hearing before a hearing examiner."

FINANCIAL DATA

The estimated cost would be \$100.00 and would be available from the Chief of Police's budget.

RECOMMENDATIONS

1. If the Council should decide to appoint a hearing examiner, it is recommended that the following motion be adopted: "The Council hereby determines pursuant to Section 2.324, City

Code, that this appeal will involve a lengthy factfinding process which will be more appropriately accommodated by a formal hearing before a hearing examiner. Therefore, the Council appoints A. J. Weiglein as hearing examiner to hear the appeal on Wednesday, October 6, 1982, at the hour of 9:00 a.m., at 3287 Fifth Avenue, Sacramento, California."

- 2. If the Council should decide to consider the appeal itself, it is recommended that the hearing be set for October 5, 1982.
