MINUTES OF REGULAR MEETING OF FEBRUARY 3, 1987

A motion was made to approve the minutes of the February 3, 1987 meeting as corrected.

REPORTS OF DIRECTOR OF PERSONNEL

Mr. John Worcester, Personnel Services Manager, informed the Board that an extension of medical leave of absence has been approved for Edison Hicks, Sanitation Worker II.

Mr. Worcester also informed the Board that in the appeal of Vivian Monteiro, which was heard at the February 3rd meeting, staff found a discrepancy in the number of hours Ms. Monteiro had worked as a Parking Lot Attendant. Ms. Monteiro is scheduled to take the Senior Parking Lot Attendant test on February 23, 1987.

RECOMMENDED DECISION OF ADMINISTRATIVE LAW JUDGE - BOB LEE, PARKING LOT ATTENDANT

Mr. Sam Jackson, Deputy City Attorney, addressed the Board on this item. Mr. Jackson informed the Board that the City had tried to reach Mr. Lee at his last known addresses several times by certified mail but the mail was returned. Mr. Jackson went ahead and had the hearing before the Administrative Law Judge without Mr. Lee present to clear the matter. Mr. Lee was notified of the hearing before the Civil Service Board but only one letter of the three sent certified has been returned.

Mr. Garland Rosauo, District Representative, Local 39 addressed the Board and informed them that Local 39 is no longer representing Mr. Lee because of not being able to contact him.

After considerable discussion by the Board, Mr. Jackson and Mr. Carnazzo a motion was made to continue this matter until the next regular scheduled meeting. The motion died for lack of second.


