SUBJECT: Sacramento Metropolitan Arts Commission/Rio Cosumnes  
Correctional Center, Phase II for the Art in Public  
Places Program, 1990

SUMMARY

This report recommends that the Budget and Finance Committee:  
1) approve the attached agreement between the City and County of  
Sacramento for administration of the Rio Cosumnes Correctional  
Center, Phase II Art in Public Places project; 2) authorize the  
City Manager to execute the agreement; 3) approve an increase in  
appropriations to the FY 1990-91 budget of the Metropolitan Arts  
Division for administration of the Rio Cosumnes Correctional  
Center, Phase II Art in Public Places project, and 4) forward  
this report to City Council with recommendation for approval.

BACKGROUND

The County of Sacramento is expanding the existing Rio Cosumnes  
Correctional Center, located at 12500 Bruceville Road in  
Elk Grove, California. The Administration and Finance Agency in  
the office of the County Executive has notified the Sacramento  
Metropolitan Arts Commission's Art in Public Places Program of  
authorization to proceed in developing and executing the art  
component for the Rio Cosumnes Correctional Center, Phase II in  
accordance with County Code sections 2.96.130 through 2.96.170.

Major provisions of the agreement between the City and County for this project include:

1. The Metropolitan Arts Commission agrees to provide the County with recommendations for the most appropriate artwork for the Rio Cosumnes Correctional Center, Phase II with a total art budget of \$36,000.
2. The County agrees to pay the City for administration of the art project a sum not to exceed \$7,760.

The total project budget for art is estimated at \$36,000 which includes an administrative budget of \$7,760. It is anticipated that \$5,230 will offset a portion of the FY 1990-91 salary budget, and \$2,530 for supplies and services.

#### FINANCIAL DATA

An increase in services and supplies appropriations in the amount of \$2,530 to the FY 1990-91 Art in Public Places Program of the Metropolitan Arts Commission is necessary for administrative costs of the Rio Cosumnes Correctional Center, Phase II. These costs will be reimbursed by the County of Sacramento and deposited in the Operating Grant Fund. An additional \$5,230 will be deposited in the Operating Grant Fund to offset salary expenses previously budgeted in FY 1990-91.


#### RECOMMENDATION


