

Sacramento, California,

December 10, 1930.

The Civil Service Board of the City of Sacramento met in special session on the above date at 1:00 o'clock P. M. in the Council Chamber of the City Hall, President Chenu presiding.

PRESENT: Commissioners Maloney, Weisman and Chenu.

ABSENT : None.

The reading of the minutes of the meeting of December 8, 1930, was dispensed with.

A request received by the Civil Service Department that they furnish a Plumber for work at the Corporation Yard, work to commence January 1, 1931, was presented to the Board. In reference to this matter, it was explained to the Board that the City Manager was desirous of having an examination held for this classification by the Civil Service Board, as soon as same was possible. Commissioner Maloney moved that applications for examination for Plumber be opened Thursday, December 11, 1930, and that applications close Monday, December 22, 1930, at 5:00 o'clock P. M.; and that the date of the examination be set for Monday December 29, 1930. This motion was seconded by Commissioner Weisman and the vote was as follows:

AYES: Commissioners Maloney, Weisman and Chenu.

NOES: None.

A communication was received from Wallace Shepard, Attorney at Law, on behalf of Mr. Ray Keating, a candidate in the examination for Patrolman. Mr. Keating was disqualified in the Athletic Test and it was Mr. Shepard's contention that elimination should not take place, but that the applicant should be allowed to complete

the examination as a whole. It was further stated by Mr. Shepard that elimination at a certain stage in the examination thus prevented the applicant from further participation and, therefore, no opportunity was afforded to appeal for a review of markings that had been given. After thoroughly discussing this case and giving full consideration to Mr. Shepard's letter, Commissioner Maloney moved that the request of Mr. Shepard, that Mr. Keating be allowed to take the written test, be denied and that the Secretary be instructed to direct a communication to Mr. Shepard referring to that Section of the Civil Service Rules pertaining to the procedure followed in the examination for Patrolman.

Commissioner Chenu relinquished the Chair to Commissioner Weisman.

The motion was seconded by Commissioner Chenu, and the vote was as follows:

- AYES: Commissioners Maloney and Chenu.
- NOES: Commissioner Weisman.

A communication was received from Mr. Peter J. Lee, a former employee in the Street Cleaning Department. Mr. Lee's letter requested the Board to give consideration to his reinstatement in the city service. Records produced showed that Mr. Lee was absent without leave from the city service which under Section 182 of the City Charter automatically severed his connections with the city. Commissioner Maloney moved that the request of Mr. Lee be denied. The motion was seconded by Commissioner Weisman, and the vote was as follows:

- AYES: Commissioner Maloney, Weisman and Chenu.
- NOES: None.

Commissioner Maloney moved that the examinations scheduled for December 11th and 12, 1930, for Patrolman and Fireman be postponed until December 18th and 19, 1930, at the same hour and place.

The motion was seconded by Commissioner Weisman, and the vote was

as follows:

AYES: Commissioners Maloney, Weisman, and Chenu.  
NOES: None.

Friday, December 12, 1930, at 7:00 o'clock P. M.
