SUBJECT: Recreation Division - Appropriation Increase for
County of Sacramento Cultural and Civic Awards Grant

SUMMARY

This report recommends an increase in appropriations of \$4,000 to the FY 1981-82 Recreation Division operating budget to reflect award of the Sacramento County Cultural and Civic Awards Grant. This grant will be used to fund the South Area Neighborhood Mural Project.

BACKGROUND INFORMATION

On December 1, 1981, the City Council adopted Resolution No. 81-886 authorizing the City Manager to submit a grant application to the County of Sacramento's Cultural and Civic Awards Program for the South Area Neighborhood Mural Project.

On December 15, 1981, the Sacramento County Board of Supervisors approved the award of a \$4,000 grant for this project. The grant is for the period of March through August 1982. The project will be contracted to local artists in addition to support provided by the Recreation Division staff.

FINANCIAL DATA

This grant does not require additional City funds. However, the Recreation Division will support the grant project through in-kind contributions.

RECOMMENDATION

It is recommended that the City Council, by resolution:

1. Approve a \$4,000 appropriation increase to the Recreation Division FY 1981-82 operating budget;
2. Authorize the City Manager to execute contractual agreements for artists;
3. Designate the City Manager as agent of the City to execute all grant-related documents.

RESOLUTION AMENDING THE CITY BUDGET FOR FY 1981-82
FOR THE DEPARTMENT OF COMMUNITY SERVICES (RECREATION
DIVISION - SACRAMENTO COUNTY CULTURAL AND CIVIC
AWARD GRANT)

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

1. The receipt of a grant from Sacramento County Cultural and Civic Award Grant to conduct the South Area Neighborhood Mural Project requires an appropriation for the budget of the Department of Community Services.
2. The City budget for FY 1981-82 is hereby amended:
 - a. By adding thereto the sum of \$4,000 to budget number 1-01-2227-8226 relating to the expenditure of funds for the grant.
 - b. The above appropriation increase is supported by revenue forthcoming from the County of Sacramento.
3. Authorizes the City Manager to execute contracts for professional services of artists.
4. Appoints the City Manager as agent of the City to execute and submit all documents including but not limited to agreements, amendments, billing statements, and so on, which may be necessary for the completion of the aforementioned mural project.
