SUBJECT: APPROVAL OF PLANS AND SPECIFICATIONS, ACCEPTANCE OF BID, AND CONSTRUCTION CONTRACT AWARD TO SHILOH ELECTRIC FOR THE TRUXEL ROAD/TERALBA-MILL OAK WAY TRAFFIC SIGNAL INSTALLATION PROJECT (PN:TG07; SN05)

LOCATION AND COUNCIL DISTRICT:

The Truxel Road/Teralba-Mill Oak Way Traffic Signal Installation Project is located in Council District No. 1. This project also includes installation of a traffic signal interconnect cable from San Juan Boulevard to West El Camino along Truxel Road.

RECOMMENDATION:

This report recommends that City Council:

- Approve plans and specifications;
- Accept low bid of Shiloh Electric in the amount of \$272,950.00; and
- Authorize the City Manager to execute a contract for the Truxel Road / Teralba-Mill Oak Way Traffic Signal Installation Project (PN:TG07; SN05).

SUMMARY:

This project involves installation of a traffic signal at Truxel Road and Teralba-Mill Oak Way including the installation of curb ramps at the corners. In addition, this project will install traffic signal interconnect cable from San Juan Boulevard to West El Camino for coordinated operation of the signals.

COMMITTEE/COMMISSION ACTION:

None.

BACKGROUND INFORMATION:

- The project was authorized in the 1999/2000 Capital Improvement Program.
- The construction estimate was \$221,800.
- Bids were received and opened on October 11, 2000 and contract award to Shiloh Electric is recommended.

FINANCIAL CONSIDERATIONS:

Staff's construction estimate cost for the bid was \$221,800. On September 20, 2000, the following bids were received:

ENVIRONMENTAL CONSIDERATIONS:

In accordance with the State Guidelines for implementation of the California Environmental Quality Act (CEQA), the Neighborhoods, Planning, and Development Services Department, Environmental Services Section, has determined that the proposed project will not have a significant effect on the environment and is categorically exempt from CEQA pursuant to Section 15301 (b) and Section 15303 (d). A notice of Exemption has been filed with the County Recorder's Office.

POLICY CONSIDERATIONS:

The action requested herein is consistent with Sacramento City Code, Title 3.

ESBD CONSIDERATIONS:

To encourage small and emerging business participation, plans and specifications were sent to 9 plan rooms and construction service organizations for publication. All are directly involved with ESBE construction firms. Staff actively recruited available ESBE firms to participate in the bid process. Project notices were sent to 30 organizations involved in ESBE recruitment. The project was also announced on the Project Information Line and on the City's Internet site at www.cityofsacramento.org/bids.
