The Civil Service Board met in special session in its office at 5:00 P.M.

Appointment Date

A letter from Mr. Holland dated
January 19, 1943, requesting that
the Board consider his appointment

date and place him on the shift from which he was removed, was considered by the Board. Mr. Holland and Carl Hoskinson, Acting Superintendent of the Water Department were present explaining the nature of Mr. Holland's work and periods of employment as Pump Operator. After discussion and review of the Pump Operator's Eligible Register, Mr. Deise moved that it be the intention of the Board that Pump Operator's Eligible Register No. 112 be abolished; seconded by Mr. Cavanaugh, thereupon becoming the order of the Board.

SADIE BUNTE

Inasmuch as George J. Raymond,
Attorney for Sadie Bunte had been
notified by letter that the Board

would consider his request as made in his letter of December 12, 1942, the Chairman announced that a hearing would be held at this time. Mr. P. M. Millspaugh appeared stating that he was appearing for Mr. Raymond and Miss Bunte. He further stated that he had no additional information to submit to the Board other than has been previously considered by the Board. After discussion and review of the number of times Miss Bunte had been certified for various positions without having been appointed, Mr. Cavanaugh moved that Sadie Bunte's name be removed from the Junior Clerk Lay-off List on the ground that she was inadvertently and without right


placed upon the eligible list after resignation from City service; seconded by Mr. Deise, thereupon becoming the order of the Board.

C. S. FISCUS
Classification

A letter dated November 25, 1943, addressed to Mr. Fred Klaus, City Engineer, was returned by Mr. Klaus

to the Civil Service Board with notation thereon that the Fender Man had assisted the Blacksmith as Blacksmith Helper for 2 hours in September, 2 hours in October and 3 hours in November. The Board again reviewed the previous request of Mr. Fiscus that he be provided with work as a Blacksmith Helper, and after discussion and agreement by Board members, it became the order of the Board that inasmuch as the Fender Man spent so little time assisting the Blacksmith, that a Blacksmith Helper was unnecessary.

There being no further business, the Board adjourned at 7:30 P.M. to meet again at the Call of the Chair.
