SUBJECT: BINGO ORDINANCE REVISIONS

SUMMARY

This report requests that the Law and Legislation Committee recommend the City Council adopt: (1) the attached ordinance which strengthens the City's regulatory provisions of bingo games; and (2) the attached resolution which directs staff to present to the City Council within 120 days the results of discussions to propose joint City/County regulations to assure that bingo games are operated for charitable purposes.

BACKGROUND

On Thursday, March 31, 1988 staff presented the attached report regarding bingo ordinance revisions to the Committee. After hearing public testimony, the Committee directed staff to meet with the licensed bingo operators and report back to the Committee concerning:

1. alternatives to increase the amount of bingo proceeds donated to charity
2. pull tab operations
3. annual bingo report financial data which separately identifies the prize expenses of each bingo licensee

DISCUSSION

Staff invited all City bingo licensees to participate in a work session on April 14, 1988 to discuss the cause of and solutions to the problem of the decline of bingo proceeds donated for charitable purposes. Representatives of 11 bingo organizations attended the work session.

The attendees unanimously agreed that if bingo proceeds continue to decline, the charities will be forced to discontinue this method of fundraising. The primary cause of the decline is the increased competition for the local

available gambling dollars. The competition includes City bingo licensees, County bingo licensees, and Indian bingo operators. It may be feasible to limit the competition caused by City and County bingo licensees. It is not feasible to limit the competition by the Indian bingo operators who are exempt from state and local regulation.

Competition caused by City and County bingo licensees has decreased the profitability of all the licensees. To attract bingo players, City and County bingo licensees have resorted to prize giveaways and guaranteed \$250 jackpot payoffs for each game. These promotions raise the fixed costs and are only effective until competing bingo licensees follow suit. Once a majority of the bingo licensees match the promotions, the result is a higher operating cost for everyone without a matching revenue increase.

The attendees unanimously stated that control of competition must be equally applied to City and County bingo licensees. Separate attempts to control competition would be less effective than a joint effort. In the event either the City or the County separately adopt regulations limiting competition, the licensees operating with the most liberal regulations would flourish at the expense of the stricter regulated licensees.

None of the work session attendees supported staff's proposal to require a minimum 20% charity donation of bingo gross receipts as a means to limit unprofitable competition.

The other methods proposed at the work session to alleviate the decline in bingo game proceeds donated for charitable purposes included:

1. Restrictions on the maximum total dollar amount of prizes that can be offered at each bingo session
2. Elimination of prize giveaways
3. Restriction on the number of bingo sessions held per week
4. Restriction on the number of sessions held per week at a single location.

The City of Los Angeles is considering adopting a minimum 25% charity donation requirement. The State of Washington has imposed a minimum charitable donation requirement in which the minimum percentage required for charity donation increases as bingo gross receipts increase. This concept, although unpopular with the bingo licensees, is effective.

Staff remains convinced that the success of bingo activities as a method to raise funds for charitable purposes will decline without the imposition of new regulations. The City and County should adopt joint regulatory provisions to protect this means of charitable fundraising. In the event a joint accord is not reached, City staff should be directed to present the necessary regulatory provisions to assure that bingo games in the City are operated for charitable purposes.

The City should initiate formal discussions with the County staff and the City and County bingo licensees to achieve this goal. Previous discussions between the City and County have not resulted in the adoption of similar bingo license regulations. The decline in charitable donations, however, necessitates a reconsideration of the regulations by both the City and the County. Staff requests that the Committee impose a 120 day limit on the time allowed for the discussions. If the discussions are unfruitful, the City will have three options to consider. These are:

1. Retain status quo.
2. Adopt regulations that assure bingo games in the City are operated for charitable benefit.
3. Prohibit bingo games within the City.

Option 1 will likely result in the elimination of bingo games as a major fundraising activity for many charitable organizations. This is especially true for the smaller-volume bingo licensees. Option 2 will adversely impact the ability of City bingo licensees to compete with County licensees and will also likely result in the elimination of bingo games as a major fundraising activity. Option 3 will definitely result in the elimination of bingo games as a fundraising activity and will eliminate social bingo games as well. None of the options produce desirable results.

The work session attendees fully supported the other regulatory proposals in the March 22, 1988 staff report.

Many bingo operators also include the sale of pull tabs as part of their bingo activities. Pull tabs closely resemble the California Lottery scratch-off games. A player must buy pull tabs on the premises where bingo is conducted. As with the State Lottery scratch-off games, the player uncovers the game symbols to ascertain if a prize is won. Pull tab games guarantee a fixed return, usually in excess of twenty percent, for the bingo licensee. The licensees who attended the work session explained that pull-tab profits often offset unprofitable bingo games that include a guaranteed \$250 fixed payoff.

Exhibits I and II detail the bingo prize expense for each City licensee. Exhibit I alphabetically lists the licensees and Exhibit II lists the licensees based upon the net profit.

RECOMMENDATION


It is requested that the Law and Legislation Committee recommend that the City Council:

1. Adopt the attached ordinance which amends regulatory provisions relating to bingo game operations within the City; and

2. Adopt the attached resolution which directs City staff to present to City Council within 120 days the results of discussions to propose joint City/County regulations to assure that bingo games are operated for charitable purposes.

SUBJECT: BINGO ORDINANCE REVISIONS

SUMMARY

This report requests that the Law and Legislation Committee recommend the City Council adopt the attached ordinance which establishes a minimum 20% charity donation of gross bingo receipts and provides technical administrative improvements of the present regulatory provisions.

BACKGROUND

Bingo games have been legally allowed to operate in the City since 1977. In 1983 the City conducted a thorough review of the bingo regulatory provisions and adopted the present ordinance effective August 1, 1983.

DISCUSSION

Bingo activity in the City is jointly monitored by the Police Department and the Revenue Division. Police Department and Revenue Division staff are concerned that the original intent of legalizing bingo to produce revenue for charitable purposes has been violated. Additionally, Police Department staff is concerned that the present regulations are unclear about prohibiting electronic or mechanical bingo games. Revenue Division staff believes that certain regulatory provisions should be revised to facilitate monitoring of bingo activities.

The joint concern that the original intent of legalizing bingo has been violated stems from the steady decline in the percentage of gross receipts reported donated to charity, from 20.3% in 1982 to 4.2% in 1987. During 1987, one charity suffered a net loss of \$122,587. Exhibit I lists the 1987 bingo licensees in the order of percentage of retained net earnings available for donation to charity.

The amount of money spent on fund raising appears to be excessive. The National Charities Information Bureau has a proposed standard that a maximum of 40% of monies raised by charities should be used for fund raising activities. City staff recognizes that bingo fund raising differs from direct mail fund raising and that bingo fund raising costs are higher.

Imposing a requirement that a minimum percentage of the gross receipts must be donated for charitable purposes will assure that the bingo games of organizations with monthly gross receipts in excess of \$5,000 are operated to produce revenue for charitable purposes. An additional requirement that the charity must have been in existence for three years prior to receiving a bingo license will assure that the organization is truly a charitable organization. The attached ordinance requires a minimum donation of 20% of the gross receipts for charitable purposes for any bingo licensee that has monthly gross receipts in excess of \$5,000.

Police Department staff is concerned that the present regulations are unclear about prohibiting electronic or mechanical bingo games because these games resemble slot machines. Police Department staff recommends expressly prohibiting electronic or mechanical bingo games to remove any doubt regarding their legality.

Revenue Division staff recommends the following revisions of the regulatory provisions to facilitate monitoring of bingo licensees.

1. Require licensees to advise the City in writing within 10 days of any changes in the information provided by the organization on the bingo license application.

Comment: This will assure that the City's license files are current.

2. Delete the 50% refund of the bingo license application fee for applications that are denied.

Comment: The City experiences higher costs rather than lower costs when a license is denied.

3. Authorize the City Manager to waive the annual license fee for any organization conducting bingo games solely for the purpose of the organization's entertainment.

Comment: The annual fee creates a financial hardship for an organization conducting bingo games solely for its entertainment.

4. Impose a penalty for late payment of annual and monthly license fees.

Comment: The penalty will encourage timely payment of annual and monthly license fees.

5. Impose a deadline for submittal of annual financial reports.

Comment: The deadline will encourage timely filing of the annual financial reports.


March 22, 1988

The current bingo licensees were informed of these proposed changes and were requested to provide comments. All of the licensees that responded opposed the requirement for a minimum charity donation of gross receipts. One licensee opposed waiving the \$50 annual fee for organizations conducting bingo games solely for their entertainment.

RECOMMENDATION


It is requested that the Law and Legislation Committee recommend the City Council adopt the attached ordinance which establishes a minimum 20% charity donation of gross bingo receipts and provides technical administrative improvements of the present regulatory provisions.

ORDINANCE NO.

ADOPTED BY THE SACRAMENTO CITY COUNCIL ON DATE OF

AN ORDINANCE AMENDING SECTIONS 18.102,
18.105(a) AND 18.106, AND ADDING SECTIONS
18.116-1, 18.130 AND 18.131 TO THE
SACRAMENTO CITY CODE, RELATING TO BINGO

BE IT ENACTED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

SECTION 1.

Section 18.102 of the Sacramento City Code is hereby amended to read as follows:

Sec. 18.102 Organizations eligible for license.

Organizations which are exempted from the payment of the bank and corporation tax by sections 23701a, 23701b, 23701d, 23701e, 23701f, 23701g, and 237011 of the Revenue and Taxation Code and mobilehome park associations and senior citizens organizations are eligible to apply for a license to conduct bingo games in the city under the provisions of the California Constitution, section 326.5 of the Penal Code and provisions of this chapter; provided that the receipts of such games are used only for charitable purposes, and provided further that no organization shall be eligible to apply for a license unless the organization has been in existence for three years or longer.

SECTION 2.

Subsection (a) of Section 18.105 of the Sacramento City Code is hereby amended to read as follows:

- (a) The name of the applicant organization, and a statement that the applicant is an eligible organization under Section 18.102, and proof that the organization has been in existence for three years or longer.

SECTION 3.

Section 18.106 of the Sacramento City Code is hereby amended to read as follows:

Sec. 18.106 License fee.

An annual license fee of \$50 shall accompany the application. ~~If an application for a license is denied, one half of the application fee shall be refunded to the organization.~~ In addition to the \$50 annual fee, a fee of one percent (1%) of the monthly gross receipts over \$5,000 derived from bingo games shall be paid monthly by the organization to the city. Said fee shall be paid to the city within 15 days after the end of the month for which the fee is due, and shall be accompanied by a completed monthly income and expense statement on a form provided by the city manager. If the monthly fee is not paid within 30 days after the end of the month for which it is due, a penalty of \$15 shall be added to the unpaid amount. After 30 additional days, if the fee is still delinquent, an additional penalty of \$100 shall be added to the unpaid amount to cover the costs of enforcement.

The city manager may waive the annual license fee for any organization, such as a senior residence complex, senior center, or social club, which conducts bingo games solely for the entertainment of its members or residents and which has gross receipts derived from bingo games of less than \$1,000 per month.

Nothing in this section shall be construed to require any refund of license fee paid in the event a bingo license is revoked under the provisions of this article. (Ord. 3850, \$1; Ord. 3966, \$2; Ord. 83-089, \$1)

SECTION 4.

Section 18.116-1 is hereby added to the Sacramento City Code to read as follows:

Sec. 18.116-1 Minimum charitable contributions.

- (a) Notwithstanding the provisions of Section 18.116 or any other provision of law, a licensee which for any month has gross receipts derived from bingo in excess of \$5,000 shall use for charitable purposes no less than twenty percent (20%) of its total gross receipts derived from bingo games, calculated on an annual basis. The city manager shall establish reasonable regulations for measuring compliance with this requirement.
- (b) Every licensee shall comply with subsection (a) for the calendar year beginning January 1, 1989 and at all times subsequent thereto.
- (c) No bingo license shall be renewed on or after January 1, 1990, unless the licensee has, for all periods commencing January 1, 1989 to the time of renewal, complied with subsection (a).

SECTION 5.

Section 18.130 is hereby added to the Sacramento City Code to read as follows:

Sec. 18.130 Electronic and mechanical devices prohibited.

No licensee shall offer or operate, or allow to be played, any form of bingo in which electronic or mechanical machines or devices are utilized.

SECTION 6.

Section 18.131 is hereby added to the Sacramento City Code to read as follows:

Sec. 18.131 Other reporting requirements.

- (a) A licensee shall advise the city manager in writing within ten (10) days of any change in the information contained on the licensee's application for license.
- (b) Every licensee shall file an annual financial report of its bingo operations no later than January 31 of each year for the prior calendar year. The city manager shall prescribe the form and manner of the annual report.

BE IT ENACTED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

SECTION 1.

Section 18.102 of the Sacramento City Code is hereby amended to read as follows:

Sec. 18.102 Organizations eligible for license.

Organizations which are exempted from the payment of the bank and corporation tax by sections 23701a, 23701b, 23701d, 23701e, 23701f, 23701g, and 23701l of the Revenue and Taxation Code and mobilehome park associations and senior citizens organizations are eligible to apply for a license to conduct bingo games in the city under the provisions of the California Constitution, section 326.5 of the Penal Code and provisions of this chapter; provided that the receipts of such games are used only for charitable purposes, and provided further that no organization shall be eligible to apply for a license after April 15, 1988 unless the organization has been in existence for three years or longer.

SECTION 2.

Subsection (a) of Section 18.105 of the Sacramento City Code is hereby amended to read as follows:

- (a) The name of the applicant organization, and a statement that the applicant is an eligible organization under Section 18.102, and proof that the organization has been in existence for three years or longer.

SECTION 3.

Section 18.106 of the Sacramento City Code is hereby amended to read as follows:

Sec. 18.106 License fee.

An annual license fee of \$50 shall accompany the application. If an application for a license is denied, one-half of the application fee shall be refunded to the organization. In addition to the \$50 annual fee, a fee of one percent (1%) of the monthly gross receipts over \$5,000 derived from bingo games shall be paid monthly by the organization to the city. Said fee shall be paid to the city within 15 days after the end of the month for which the fee is due, and shall be accompanied by a completed monthly income and expense statement on a form provided by the city manager. If the monthly fee is not paid within 30 days after the end of the month for which it is due, a penalty of \$15 shall be added to the unpaid amount. After 30 additional days, if the fee is still delinquent, an additional penalty of \$100 shall be added to the unpaid amount to cover the costs of enforcement.

The city manager may waive the annual license fee for any organization, such as a senior residence complex, senior center, or social club, which conducts bingo games solely for the entertainment of its members or residents and which has gross receipts derived from bingo games of less than \$1,000 per month.

Nothing in this section shall be construed to require any refund of license fee paid in the event a bingo license is revoked under the provisions of this article. (Ord. 3850, \$1; Ord. 3966, \$2; Ord. 83-089, \$1)

SECTION 4.

Section 18.130 is hereby added to the Sacramento City Code to read as follows:

Sec. 18.130 Electronic and mechanical devices prohibited.

- (a) No licensee shall offer or operate, or allow to be played, any form of bingo in which electronic or mechanical machines or devices replace the traditional paper or cardboard bingo cards.
- (b) No licensee shall offer or operate, or allow to be played, any form of bingo in which the numbers to be called by the house are selected by electronic means rather than by taking numbered balls from a pool of game balls.

SECTION 5.

Section 18.131 is hereby added to the Sacramento City Code to read as follows:

Sec. 18.131 Other reporting requirements.

- (a) A licensee shall advise the city manager in writing within ten (10) days of any change in the information contained on the licensee's application for license.
- (b) Every licensee shall file an annual financial report of its bingo operations no later than January 31 of each year for the prior calendar year. The city manager shall prescribe the form and manner of the annual report.
