
RECOMMENDATION:

SUBJECT: Granite Quarry Landfill EIR

## SUMMARY

The City Council-appointed Landfill EIR Selection Committee has evaluated seven proposals and interviewed personnel from five EIR proponents to recommend that a contract be negotiated with Jones & Stokes Associates, Inc. to conduct the required landfill Site Technical Study and EIR.

## BACKGROUND INFORMATION

On March 5, 1985 the City Council appointed a Selection Committee to determine the consultant firm that would prepare a Granite Quarry Landfill Site Technical Study and EIR.

The Selection Committee evaluated proposals from:

On March 15, 1985 the Selection Committee interviewed personnel from five of the seven EIR firms (see bracketed above). As a result of the evaluations and interviews, the Selection Committee recommends that Jones & Stokes Associates, Inc. of 2321 P Street, Sacramento, CA 95816 be contracted to provide the requisite EIR/Site Technical Study consultant services.

## FINANCIAL DATA

City Council Resolution No. 84-658 amended the Solid Waste Division's 1984-85 Budget to add the \$75,000 to pay for a landfill EIR on the Granite quarry site.

To insure adequate funds for the Granite quarry landfill EIR and the required Site Technical study, Public Works Solid Waste has proposed a \$60,000 CIP (85-3140-004) in 1985-86. Thus, it is proposed herein that Solid Waste's 1984-85 Budget be amended to add \$60,000 and CIP No. 85-3140-004 be deleted from the 1985-1990 CIP Programs. This later action would provide the total funding necessary to negotiate an EIR contract in 1985.

RECOMMENDATION

Staff recommends that the City Council approve the attached resolution to amend the Solid Waste Division's 1984-85 Budget and to designate the City Manager to execute an EIR/Site Technical Study Contract with Jones & Stokes Associates, Inc.

RESOLUTION AMENDING THE CITY BUDGET FOR FISCAL YEAR 1984/85 AND AUTHORIZING THE EXECUTION OF AN AGREEMENT FOR CONSULTANT SERVICES TO PREPARE THE GRANITE QUARRY LANDFILL EIR

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

1. The amount of \$60,000 together with the \$75,000 originally budgeted for this project will provide sufficient funds to the consultant, Jones and Stokes Associates, progress pay for work performed, and all incidentals associated with the EIR.
2. That the City Budget for Fiscal year 1984/85 is hereby amended by transferring the sum of \$60,000 from Account 4-15-7021-0000-4399 to Account 4-15-3141-0000-4258 to pay for an Environmental Impact Report of the Granite Quarry site as the location of a landfill.
3. That the City Manager and City Clerk are hereby authorized to execute a contract between the City of Sacramento and Jones and Stokes Associates, Inc. for the preparation of an Environmental Impact Report/Site Technical Study at the Granite quarry. The contract executed shall be for an amount not to exceed \$135,000.
