BACKGROUND

On June 10, 1980, the Agency entered into a Contract for Personal Services with Data Planning and Control Systems. Pursuant to this contract John P. G. Stiles of Data Planning and Control Systems was hired to serve as Acting Project Manager of the Property Rehabilitation Department. Mr. Stiles was hired to fill the void left by the resignation of the former Project Manager until such time as a permanent replacement could be found. Under the general direction of the Assistant Director of the Research and Development Division, his primary duties are to respond to and resolve any complaints regarding rehabilitation work and to provide overall direction, technical, administrative and management services to help ensure optimum production within the Rehabilitation Department. This current contract is scheduled to terminate August 7, 1980.

The Agency has recently hired a permanent Project Manager who is scheduled to begin work on August 25, 1980. In order to provide a transition period and help insure continued progress toward attaining rehabilitation goals, the Agency desires to amend the existing Contract with Data Planning and Control Systems. This Amendment would extend the contract time until September 5, 1980, which would provide a two week transition period in which to acquaint the new Project Manager with Agency operations.
