SUBJECT: CONTRACT FOR HOUSING OF CITY PRISONERS

SUMMARY

The contract with the Sacramento Sheriff's Department for care of city prisoners expired on December 20, 1979. A resolution authorizing a new contract must be adopted by the Council. The contract should then be signed by the City Manager.

FINANCIAL DATA

The old rate, calculated in 1976, was \$17.89 per day. Because of rising costs and inflation in recent years, the new rate has been calculated at \$23.88. (See attached.) The actual annual amount is dependent upon the number of people arrested by the Police Department for City Code violations.

RECOMMENDATION

It is recommended that the City Council adopt a resolution authorizing a new contract for care of city prisoners.

RESOLUTION AUTHORIZING CITY MANAGER TO EXECUTE
CONTRACT WITH COUNTY OF SACRAMENTO FOR HOUSING
OF CITY PRISONERS

WHEREAS, the provisions of Section 36903 of the
Government Code provides that imprisonment for violation
of a City ordinance in the County jail shall be an expense
charged against the City; and

WHEREAS, the City and County of Sacramento have
negotiated a fixed rate of \$23.88 for reimbursement of
expenses incurred by the County of Sacramento for the
imprisonment of each City prisoner per day;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF
THE CITY OF SACRAMENTO:

That the City Manager is hereby authorized to
execute that certain agreement with the County of Sacramento
for the reimbursement of expenses relating to the
imprisonment of City prisoners in the County jail at the
rate of \$23.88 per prisoner per day.
